Summary of key findings

This provision meets requirements

- The knowledgeable manager knows how to provide an exciting play environment that motivates and interests all children. She is able to set out a wide range of activities, using well-maintained resources, both indoors and in the school garden. She describes flexible planning to meet children's need to be active or relax at the end of the busy school day.
- During the inspection, the manager spoke about the importance of supporting children to make healthy lifestyle choices. She described the simple cooking activities planned for the children, such as smoothie making, that help children to learn about healthy food. There are consistent measures in place to support children to follow good hygiene routines and become independent in their self-care.
- The provider and manager have a good understanding of how to manage children's behaviour using positive strategies. They discuss how they follow methods used by school staff, such as clapping to gain the children's attention. This helps to give children continuity. The provider and manager recognise the need to model respect and tolerance, and help children to understand the effect of their behaviour on others.
- The provider and manager work in close partnership with the school. They share information to help to ensure children's health and care needs are fully understood and met. The provider understands the need to work in partnerships with parents. She describes the comprehensive information obtained from parents and the careful settling-in process, to ensure children feel secure when they start at the club.
- The provider gives good support for the manager through an effective performance management system, including daily contact. The manager is able to access regular training to improve her skills and knowledge even further. She is confident and happy in her role, which helps to provide a positive environment for the children.
- The manager conducts regular risk assessments of the areas used by the children. The provider monitors accidents and takes action to minimise these. The provider and manager have a very good understanding of the need to be vigilant about children's welfare and the signs that might indicate a safeguarding concern. They know the procedures to follow and how to report these.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The provider discussed with the inspector how the club is run and how legal requirements are met.
