Summary of key findings

This provision meets requirements

- The manager fully understands how to effectively safeguard children's welfare and keep them safe. For instance, she knows what safeguarding and child protection procedures to follow if an issue was to arise. The manager knows who to contact to raise and follow up potential concerns.
- The manager understands the importance of establishing positive partnerships with parents. For example, she knows the benefits of routinely sharing children's achievements.
- The manager has a secure understanding of the benefits of building and maintaining good communication with other early years professionals. For instance, sharing information about the child's achievements with the teachers at the schools they attend.
- The manager knows how to effectively review and evaluate her practice. For example, she carries out regular independent reading and research to help her keep up to date with current early years practice.
- The manager recognises the importance of planning a wide variety of experiences and opportunities for children. She knows how to keep children motivated and interested in their play at the club.
- The manager understands the benefits of supporting children to develop positive attitudes and values. For instance, she knows how to encourage them to be polite, kind, empathetic and behave well.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The setting employs three members of staff, one of whom holds a relevant early years qualification at level 3.

- Written documentation was reviewed. This included safeguarding and child protection policies and procedures.
- The inspector spoke to the manager about intended practice and considered her views.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
