## Summary of key findings

#### This provision meets requirements

- The manager and staff team describe how they attend regular child protection training to help keep their safeguarding knowledge up to date. Through discussion, the manager shows a good understanding of how to recognise the signs of abuse. She describes the procedures she will follow if she is concerned about a child's welfare. The manager shares the procedures that are in place to complete regular risk assessments of the premises, to help minimise hazards and promote children's safety.
- The manager talks about how she intends to build positive relationships with children and support their emotional well-being from the start. The manager describes how she will work closely with parents to gather key information about their child's care needs and interests. This information will be used to plan familiar daily routines and play equipment to help children settle in.
- The manager has considered arrangements for managing children's behaviour. Through discussion, she shares the importance of implementing consistent rules, expectations and boundaries, to help promote positive attitudes and behaviours at the club.
- The manager shares the arrangements she has in place to evaluate the quality of her setting. She talks about how she will gather the views of staff, parents, children, and other professionals, to help maintain a good quality service.
- The manager describes the arrangements she has in place for the supervision of staff. She recognises the importance of staff accessing regular training for their continued professional development.
- The manager shares the arrangements in place for children to have access to healthy meals and daily outdoor play. She intends to promote the good health of children at the club.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- This was the first routine inspection the club received since the COVID- 19 (coronavirus) pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken this into account in her evaluation of the provider.
- The inspector and manager reviewed the areas of the premises used for the care of children.
- Relevant documentation was reviewed by the inspector, such as the suitability checks in place for all adults living and working on the premises.
- The inspector considered the manager's plans for working in partnerships with parents and other professionals.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
