What is it like to attend this early years setting?

The provision is inadequate

Children's safety and well-being are not assured. The childminder has a limited knowledge and understanding about some aspects of safeguarding. Children are at risk from hazards that have not been removed or minimised by the childminder in her home and garden.

Children's ability to make good progress is poor. This is because the childminder does not frequently assess their learning or plan effectively to build on what they already know and can do. As children move happily from one activity to another, the childminder follows them around watching and, at times, talking to them about what they are doing. However, children's individual learning needs are not recognised or purposefully promoted. In spite of this, children show curiosity and develop some knowledge and understanding as they play with the colourful range of toys and equipment available. For example, they practise their physical skills while carefully stacking different-sized boxes on top of each other and then knocking them down. Young children have a close and caring relationship with the childminder and are happy in her care. They look to her for support and show a growing confidence as they interact with visitors, making noises and gestures with their arms to prompt engagement.

What does the early years setting do well and what does it need to do better?

- The childminder shows a poor understanding of safety. Her risk assessments do not effectively identify all hazards to children in her home and garden. For example, children are not prevented from accessing the greenhouse that contains a large number of glass panes that do not meet British Safety European Norm standards. In addition, a barrier intended to separate children from the childminder's pet dog is not secure and can be easily moved. These hazards put children at direct risk of harm and do not ensure their safety and well-being are effectively promoted.
- The childminder has failed to maintain a current paediatric first-aid qualification. As a result, children are not assured of appropriate emergency care in the event of an accident. In addition, the childminder does not consistently maintain a record of accidents, injuries or any first-aid treatment administered to children. This does not promote the good health and well-being of children in her care or help to highlight any patterns of concern.
- Since registration, the childminder has not completed any ongoing professional development. She shows significant weaknesses in her understanding of the importance of assessment for learning to support children's development. Curriculum planning does not currently consider what each child knows and can do, what they need to learn next and how they will achieve this. This, in turn, has a negative impact on the quality of progress children can make.



- The childminder's lack of assessment limits her ability to consistently exchange meaningful information about children's learning and development with their parents, or staff at other settings that the children attend. As a result, they are not able to support children's individual progress effectively. In addition, the childminder does not receive accurate information about each child's achievements when they are not in her care.
- The childminder's expectations for young children's behaviour is appropriate for their level of understanding. She uses gestures and tone of voice to make her meaning known.
- Children's times of arrival and departure are maintained effectively by the childminder whenever they attend.

Safeguarding

The arrangements for safeguarding are not effective.

The childminder has failed to complete regular safeguarding training or keep her knowledge up to date. As a result, her understanding of child protection is weak. For example, she does not have a sufficient understanding of wider safeguarding issues, such as female genital mutilation and her responsibilities under the 'Prevent' duty guidance. This severely inhibits the childminder's ability to protect the safety and welfare of children in her care.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:
