Summary of key findings

This provision meets requirements

- Leaders and staff understand their responsibilities to provide activities that meet children's individual needs and interests. They know how they will provide a program of events while complementing the learning children receive at school.
- Leaders and staff know how to promote children's health. They understand the benefits of healthy eating and providing children with daily opportunities for exercise and outdoor activities. The environment which they have available for children is safe and secure.
- Leaders and staff know how they would manage children's behaviour in a positive way. They understand the methods they would use to teach children to take turns, be kind and share.
- Leaders and staff know how they would work in partnership with parents, professionals and other settings children attend. They understand how they would support continuity in children's care.
- Leaders and staff understand how they would evaluate their service. They recognise the importance of professional development opportunities to support personal and professional development.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- A sample of documentation was viewed by the inspector, including children's records, staff qualifications and staff suitability.
- The inspector spoke to leaders and staff about how they safeguard children and meet the individual needs of the children.
