Overall outcome

The school is unlikely to meet the relevant independent school standards if the material change relating to the school provision is implemented

Main inspection findings

Part 1. Quality of education provided

- The Department for Education commissioned the inspector to review proposed provision for an increase in age range from 7 to 11 years old. However, resources and classroom space are only suitable for the current pupils in the school. The increase in age range above Year 3 is not recommended at this inspection.
- Leaders have put in place a written curriculum policy. Plans are detailed. They set out the skills and subject knowledge that pupils should be taught in each subject. However, these plans only provide for pupils up to Year 4. There are no plans in place for pupils in Years 5 and 6.
- The curriculum includes a wide range of subjects. These match the ambition of the national curriculum. Leaders have made sure that the curriculum plan in place is supported by schemes of work for each curriculum area. For example, there are schemes of work, daily lesson plans and resources ready for teachers to use in Years 3 and 4 for subjects such as history and geography.
- Leaders have mapped out personal, social, and health education (PHSE) provision up to Year 4. Leaders have not mapped out how they will promote older pupils' PSHE development.
- Teachers will check on the progress that pupils in Year 3 are making during lessons. They will check pupils' understanding against end of year expectations in each subject. Pupils will have targets to work towards. Their progress will be measured against the achievement of these targets.
- Parents and carers will get regular updates on their children's progress. They will receive an annual report that will outline progress in each curriculum area.

■ The proprietor body has not ensured that all of the independent school standards (standards) in this part are likely to be met.

Part 2. Spiritual, moral, social and cultural development of pupils

- The relevant policies and schemes of work set out learning designed to give pupils an understanding of fundamental British values. However, these are only mapped out up to Year 4. Staff plan to teach children the spiritual, moral, social and cultural aspects of the curriculum through lessons and assemblies. Leaders have also planned visits and visitors to the school for the current pupils.
- The proprietor body has not ensured that all of the standards in this part are likely to be met.

Part 3. Welfare, health and safety of pupils

Paragraph 7, 7(a), 7(b) 32(1)(c)

- There is a suitable safeguarding policy in place. The policy is in line with current statutory guidance. As there is no website, the safeguarding policy is available in hard copy to parents.
- A single central record of employment checks that meets legal requirements is in place. Leaders state that they will update the register as new members of staff are recruited.
- The proprietor body has ensured that senior leaders are trained as qualified designated safeguarding leads. Staff are trained to safeguard pupils. Curriculum plans show that pupils learn about possible risks and how to keep themselves safe, for example regarding fire safety and personal safety.
- The proprietor body has ensured that all of the standards in this part are likely to be met.

Part 8. Quality of leadership in and management of schools

Paragraph 34(1), 34(1)(a), 34(1)(b) and 34(1)(c)

- Leaders have paid attention to the preparation of the Year 3 classroom, preparation of documents and plans that support this year group. The resources and building are not currently suitable for any additional year groups.
- The proprietor body and headteacher have ensured that pupils' welfare is a key priority. The chair of the proprietor body holds leaders to account. He also draws on external support from local schools to help develop the school.
- The proprietor body has ensured that all of the standards in this part are likely to be met.

■ Leaders have developed a suitable accessibility plan. It is designed to meet pupils' needs in regard to the curriculum and accessing the building.
