

# Eton Dorney Independent Therapeutic School

34 Lake End Road, Dorney, Berkshire SL4 6QS

**Overall outcome** 

The school does not meet all of the independent school standards that were checked during this inspection

## Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraph 7, 7(a), 7(b), 9(a), 9(b), 9(c), 11, 12, 14, 16(a), 16(b) and 16(c)

- Leaders have ensured that all health and safety policies are compliant and updated in accordance with national guidance issued by the Department of Education (DfE). The school's safeguarding policy and accompanying documents are compliant with government guidelines.
- The school's arrangements to ensure pupils' welfare and safety are not effective. Behaviour records show that staff report all incidents of poor behaviour. However, the records do not show the decisions or actions taken by leaders to address serious breaches of the school's behaviour policy. Although senior leaders say that they share information about consequences with staff and pupils, there are no detailed records of these. There is a lack of monitoring of pupils' welfare and safety. Pupils who spoke to the inspector told her that they do not feel safe. They do not trust that staff will help them deal with any concerns they may have.
- The headteacher has made changes to some aspects of the health and safety policies. Staff have received training and only use physical restraint as the very last resort. Leaders make sure that risk assessments are timely. They share the risk assessments with pupils, parents and carers. However, leaders' oversight of how well the risk assessments support pupils' welfare is poor. Too often, risk assessments do not include clear timelines, clarity around actions to reduce risks or an end date.
- Leaders make sure that fire safety policies and procedures are met diligently. Staff are well informed of the fire safety procedures and receive regular training. Pupils know how to respond in the event of a fire. Any breach of the fire policy is monitored and addressed quickly.
- The single central register of checks on adults is maintained correctly. All the required checks are recorded. Key staff have attended training about safer recruitment. Leaders have also ensured that key staff are qualified to carry out additional safeguarding responsibilities.
- Pupils say that they learn about safety at school. They can recall learning about keeping safe online and fire safety. However, some pupils do not feel that staff help



them learn how to look after their physical, emotional or mental health. Pupils told the inspector that too often, their learning is disrupted by poor behaviour.

- The standard relating to effective implementation of a written behaviour policy and risk assessments is not met.
- Leaders have not ensured that all relevant standards in part 3 are met.

#### Part 5. Premises of and accommodation at schools

#### Paragraph 25

- The proprietor and headteacher make sure that the site is safe, secure and well maintained. Classrooms are clutter free and well ventilated. Pupils work in wellresourced specialist rooms for their art, computing, design and food technology lessons. Leaders diligently carry out regular health and safety checks of the site and essential equipment. They are quick to address any maintenance requests identified by staff.
- The premises are clean and bright. Lighting and acoustics are suitable in teaching and communal spaces. External lighting ensures that staff and pupils can enter and exit the buildings safely. Drinking water is available and suitably labelled. Facilities such as toilets and washing facilities for staff and pupils are modern and equipped well.
- The play area and school grounds are well maintained. Pupils access a range of activities they can enjoy at playtimes. For example, the site facilities include the forest school, climbing area and the large swing.
- Leaders have ensured that all relevant standards in part 5 are met.

#### Part 8. Quality of leadership in and management of schools

#### Paragraph 34(1), 34(1)(a), 34(1)(b), 34(1)(c)

- Leaders and most staff are new to the school. The proprietor has not ensured that there is effective implementation or oversight of important risk assessments and behaviour management systems. Some aspects of pupils' welfare and safety are not as effective as they should be. Several of the independent school standards relating to welfare, health and safety are not met.
- The headteacher sets high expectations and has worked well to appoint new staff and improve morale. She has rightly identified the need to urgently strengthen the behaviour management records and monitoring of risk assessments. The leadership team has not had time to demonstrate significant impact on helping pupils feel safe.
- The headteacher has introduced a new staffing structure and set clear lines of accountability. She is also making sure that leaders are well trained in their areas of responsibility and effective in their roles.
- The proprietor has appointed a director of education to oversee standards on their behalf. The headteacher is supported by the director of education, who provides external challenge.
- Leaders have not ensured that all standards in this part are met.



## **Compliance with regulatory requirements**

The school does not meet the requirements of the schedule to The Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. Not all of the standards and associated requirements were checked during this inspection.

### Information about this school

- The school was registered by the Department for Education in December 2017. The school accepted its first pupils in March 2018.
- The school's first standard inspection took place in November 2018, when it was judged to be good and all independent school standards were found to be met. The school was also subject to a material change inspection because of a request to increase pupil numbers to 50 from January 2021.



- The current headteacher was appointed in June 2021. Most of the leaders and staff joined the school in September 2021. Governance is provided by a range of proprietor's officers and an independent director of education appointed by the proprietor.
- Pupils at the school have social, emotional and mental health issues. Some pupils also have autism spectrum disorder. All pupils have an education, health and care plan.
- The proprietor is Calcot Services for Children Limited, which also runs a number of children's homes across Berkshire, South Oxfordshire and Hampshire. Eton Dorney is one of two schools belonging to the proprietor.
- The school does not use any alternative provision.



## Information about this inspection

- This was an emergency inspection carried out under section 109(1) and (2) of the Education and Skills act 2008. The inspection was commissioned by the Department for Education as a result of an anonymous complaint about fire safety. The inspection was carried out with 30 minutes notice.
- The inspector checked the school's compliance with some independent school standards relating to the welfare, health and safety of pupils and the quality of leadership and management.
- Not all of the independent school standards and associated requirements were checked during this inspection.
- The inspector held meetings with the deputy designated safeguarding leader, the school business manager, the headteacher and senior staff. She also met with a representative of the proprietor.
- The inspector met with pupils and staff.
- The inspector checked a range of policies and documents, including the school's single central register. She also reviewed the school's website and other records regarding the welfare, health and safety of pupils and staff.
