

# Childminder report

## Summary of key findings

### This provision does not meet requirements

- The childminder provides a limited range of activities for children, including watching television, playing on a tablet and drawing. She does not engage with parents, or the other settings that children attend, to support their learning and development.
- The childminder does not show an ability to improve the quality of the education and care she provides. At all previous inspections, she has been asked to improve how she delivers the learning and development requirements but has failed to do so. She does not evaluate her own practice or engage in professional development opportunities, to keep her knowledge up to date.
- The childminder does not understand the ways children learn. She does not assess children's achievements or plan engaging activities, which meet their individual needs.
- The childminder does not have a current paediatric first-aid certificate. This means that a trained paediatric first aider would not be available to respond to emergencies quickly. This does not promote the good health of children in her care.
- The childminder does not have a good knowledge or understanding of safeguarding issues. This includes possible signs that a child might be being abused. She would not be able to identify children who are at risk, and take prompt action to safeguard them. She does not understand the local safeguarding partnership procedures to be followed if she has concerns that a child might be being abused.
- The childminder does not know what to do if an allegation is made against her or a household member. She does not understand the role of the designated officer of the local authority. It is the childminder's responsibility to work with local statutory children's services to help keep children safe from harm but she is not familiar with those services.
- Records are not easily accessible or available. The childminder was unable to provide evidence of insurance.
- The setting is spacious, clean and tidy and suitable for the care of children. The childminder can identify risks in the environment. The raised fishpond in the garden is covered, and she carefully supervises children when they play outside.
- The childminder states that children are well behaved. She has consistent rules for them to follow. She talks to them about how it makes others feel if they are unkind.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What does the setting need to do to improve?

The provision is not meeting requirements and Ofsted intends to take enforcement action.

- The childminder provided the inspector with a sample of key documentation on request.
- The childminder showed the inspector the premises and discussed how they ensure it is safe and suitable.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
