### **Information about this children's home**

This home is operated by a private provider. It provides care for up to two children with learning disabilities.

The home does not have a registered manager. The current manager was appointed on 1 September 2021. He is in the process of applying to register with Ofsted

### **This monitoring visit**

On 28 and 29 April 2021, Ofsted undertook a full inspection. The home was judged inadequate. In response to that visit, Ofsted issued a notice of restriction of accommodation.

On 14 June 2021, 22 July 2021, 23 August 2021 and 5 October 2021, monitoring visits took place to monitor the notice of restriction. This had been adhered to. On 3 August 2021, a notice of decision to cancel the registration of the home was issued. On 16 October 2021, a third notice of restriction of accommodation was issued.

The purpose of this visit was to consider the home's adherence to the notice of restriction. The provider has adhered to the restriction of accommodation and there are currently no children living at the home.

The current manager was appointed on 1 September 2021. He is in the process of applying to register with Ofsted. This is his first position as a children's home's manager. Therefore, his skills and ability to undertake this role are currently untested.

During the visit, the inspector was informed by the service manager that the responsible individual intends to resign. The service manager will take over this position.

The provider has recruited a new independent person. The first visit by the independent person was completed in October 2021. The report related to this visit has yet to be shared with Ofsted.

The provider ensures that the home environment is checked to keep it safe. Fire equipment checks and fire drills take place regularly. This monitoring by the manager ensures that anyone who enters the home is safe and protected from harm.

The home is suitably furnished, decorated and carpeted. Some areas of the home still require a delicate touch to provide a welcoming, homely feel. However, the home environment is now ready and prepared to accept children.

The requirements raised at the previous inspection were not monitored at this visit as their end dates had not been reached.
