What is it like to attend this early years setting?

The provision is outstanding

Children are extremely happy and settle very well. They enjoy a very warm and nurturing relationship with the experienced and skilled childminder. This effectively promotes their emotional well-being. Children access a homely, welcoming and safe environment which is planned, with their needs being paramount.

Children confidently select what they would like to play with from the very wellplanned activities the childminder has provided for them. They smile broadly as they roll, poke and squish the play dough with their hands. This supports the development of their fine-motor skills and dexterity. The childminder is extremely effective in supporting their play and learning. She has high expectations of what all children can achieve. The needs of vulnerable children and those with additional needs are carefully planned for and extremely well met. Consequently, this ensures that any gaps in learning are starting to close.

Children's behaviour is excellent. The childminder is highly skilled in giving them successful reminders of how to behave as required, such as not to throw chalks or books on the floor. When children show that they enjoy throwing objects, the childminder provides alternative resources to allow them to do this safely. For instance, the childminder provides soft beanbags in the house for children who need to be able to throw. As a result, children clearly understand the rules and expectations for behaviour. Children are enthusiastic and keen to interact with the childminder, her family and any visitors. Children and the childminder visit local toddler groups, which supports children's developing social skills very well.

What does the early years setting do well and what does it need to do better?

- The childminder has an extremely good understanding of children's individual needs. She uses this knowledge to plan a clear, sequenced curriculum to enable them to achieve as well as they possibly can in their learning. She is very adept at adapting activities for children of differing abilities to ensure they can achieve successfully, such as adapting a 'wooden stacker' with cardboard tubes to support small-muscle development. The childminder clearly understands that children sometimes just need time to play alone and explore the activities and environment. She is really careful to observe and interact as appropriate while not interrupting their curiosity.
- The childminder skilfully promotes the development of children's language and communication skills. She introduces new vocabulary, such as 'crashed'. The childminder provides a running commentary as children play so they are cared for in a language-rich environment. The childminder is very skilful in being able to read children's body language and the sounds they make, in order to interpret their needs. She also ensures that she builds silence into her own



communication, giving the children appropriate time to respond.

- Children enjoy time outside and the opportunity to run around and practise their large-physical skills. They climb, throw and balance. They also explore leaves, sticks and water. Children develop a strong sense of pride and achievement as the childminder praises and encourages them successfully. She also ensures that they are able to manage the activities and tasks she provides, while offering effective and well-targeted challenge.
- Children develop a love of books and reading from a young age: they choose their favourite stories to read with the childminder. She involves them in the story, pointing to the words as she reads. Therefore, they are beginning to understand that print has meaning and the way that books and stories work.
- The childminder reflects on all aspects of her setting. She is highly motivated and has kept herself up to date very well since her last inspection. The childminder accesses plentiful professional development and reads widely about early years. Consequently, her knowledge and skills have continued to develop and she maintains a very high standard of practice. This supports her to provide the highest quality care and learning experiences for every child.
- Partnership working is exceptional and meets children's needs very well. As a result, children receive effective support and any additional help they may need. Parents share that they feel involved and included in the setting and children's learning. They say they are well supported by the childminder. They receive a detailed handover at the beginning and end of the day, to show how the children are developing and progressing and to support their well-being.

Safeguarding

The arrangements for safeguarding are effective.

Safety and safeguarding are given high priority by the childminder. She has an excellent understanding of her responsibilities in relation to keeping children safe. The childminder ensures that she completes relevant training and updates her knowledge of safeguarding regularly. This supports her to identify the signs that might indicate a child may be at risk of harm and to know the appropriate processes to follow should she have concerns about children's welfare. Children learn how to keep themselves safe, such as how to safely climb and descend the stairs. The childminder works really well with other agencies to ensure children receive the help and support they need and are safeguarded.

Inspection activities

- The inspector observed the interactions between the childminder and children and assessed the impact that this was having on children's learning.
- Parents shared their views of the setting with the inspector.
- The childminder provided the inspector with a sample of key documentation, on request.
