Information about this children's home

This home is owned and managed by a private provider. Care is provided for up to three children aged between 11 and 18 years. The home provides a therapeutic 12-month programme for children who have experienced, or are at risk of, sexual exploitation.

The home was registered in March 2016. There is no registered manager in post. The manager responsible for the day-to-day running of the home has not yet applied to register with Ofsted.

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At this interim inspection, Ofsted judged that it has declined in effectiveness.

There is no registered manager in post. The efforts of the organisation to recruit a manager are not effective. Until recently, the role of 'interim' manager was shared between other managers within the organisation. The sharing of this role caused confusion for staff and, on occasion, delayed decision-making in the best interests of the children. There is now one manager responsible for the day-to-day running of the home. However, this manager has not yet submitted her application to register as required.

Regular changes in the staff team prevent the children from building strong relationships with all staff. Some staff usually work in other homes owned by this organisation and are covering this home on a temporary basis. Casual bank staff are also supporting the home. The acting manager makes efforts to use staff that the children already know when possible. She takes this approach to try and provide some stability. The ongoing use of staff from other homes creates uncertainty for the children and the staff.

Some staff do not always follow the children's risk assessments. They are not assessing risks to children's safety effectively, according to their individual needs. As a result, on one occasion a child at high risk of sexual exploitation was at risk of significant harm when they went missing from the care of staff. For other children, some risks have reduced and there have been no recent incidents of self-harm.

Not all staff act in line with the home's statement of purpose and there are occasions of poor staff practice. Staff misconduct issues are followed through and relevant professionals are informed to ensure that children are protected. However, Ofsted has not been formally notified of one serious event in relation to poor staff practice. This prevents Ofsted's thorough oversight of safeguarding practice.

Physical intervention is rare. There has been one physical intervention since the last inspection. This was a low-level deflection technique to protect children and staff. The recording of the incident is poor. The manager's oversight identified this issue and she addressed this with a learning workshop for all staff. The impact of this learning cannot be assessed at this inspection.



There have been two complaints from children. One complaint has been followed through and the outcomes are recorded. One complaint remains ongoing.

Despite shortfalls, the children continue to make some progress. Both children's school attendance has improved. Children are well supported to keep in contact with their families. For some children this means that these important relationships are strengthening and this helps children's self-esteem and confidence.
