Monitoring visit

Information about this children's home

The provider states within the statement of purpose that this home provides longterm placements for up to three children aged between 11 and 18 years. These children may have autism spectrum disorder and/or associated conditions. The home is owned by a private organisation.

The manager has been registered with Ofsted since March 2021.

We last visited this setting on 20 and 21 May 2021 to carry out a full inspection. At this time, the home was judged to be good in all areas. The report is published on our website.

This monitoring visit

A monitoring visit was completed at the home due to a complaint received regarding the standards of care provided at the home. During this visit, no concerns were identified. Only one child currently lives at the home.

The care team has a good understanding of the child's complex needs. An effective multi-agency approach is supporting the child well. The care team works closely with other professionals from external health and social care teams. This is promoting positive outcomes for the child.

The child has made significant positive progress since moving in to the home, including with their anxieties, education, and social skills. There has been no need for physical interventions for many months, school attendance is good, and the child is now able to share their feelings calmly with carers.

To ensure the child is taking in enough nutrition, a feeding tube has been fitted. Staff have received the required training to use the device. This is being carefully monitored by trained health professionals who visit the home. The care team at the



home feed the child using the device daily. No concerns were identified regarding the management of this during the visit.

The environment has also greatly improved since the previous inspection. There are soft furnishings, pictures, fairy lights, and various other homely items. Previously, the child was unable to tolerate these items.

The two requirements made at the previous inspection were found to be met.
