#### What is it like to attend this early years setting?

#### The provision is good

Children are confident and inquisitive learners. They enjoy their time at the nursery and are keen to explore their surroundings. Staff plan activities that meet children's interests and help them to develop key skills. Babies play with plastic forks and spoons in paint, and demonstrate their new-found skills when using cutlery to feed themselves at lunchtime. Toddlers explore different textures, such as mud, water and grass and then use this knowledge to link it to well-known stories. Pre-school children develop good hand-to-eye coordination when using scissors and are proud of their achievements commenting, 'Look, I'm cutting!'

Staff ensure children follow the rules and boundaries of the nursery. They encourage children to take turns and to be kind to one another. As a result, children behave well and play cooperatively with their peers and adults alike. Staff have high expectations for children and gather key information about them when they first start. They use this to plan a broad curriculum that ensures all children make good progress from their starting points. Children gain strong independence skills. Older babies indicate the need for a drink by tapping their hand on the 'drink' picture to show staff they are thirsty. Toddlers and pre-school children pour their own drinks in their designated cups.

# What does the early years setting do well and what does it need to do better?

- Parents comment positively on the nursery and state that staff are positive and caring. They talk about how communication from staff is clear and how they can access information via the online platform.
- Management has a clear vision on improving the nursery to benefit children. Although the manager has only been in post for a short time, she is enthusiastic about investing time into the outdoor area to benefit babies. Additionally, management and staff are passionate about implementing forest school for toddlers and pre-school children to help develop their overall skills.
- Staff adopt a respectful care approach. They inform children if they need to change their nappy and ask them if they can wipe their nose so children can make informed choices.
- All children develop good communication skills, including those with English as an additional language. Staff gather information about children's backgrounds, cultures and sounds that they can say, to help support their overall language development. Staff use key words in children's home language, coupled with sign language to help children communicate their needs.
- Overall, children have formed secure attachments to staff and demonstrate positive interactions. At times, new babies sometimes become unsettled as the key-person system is not fully embedded to help them feel consistently safe.
- Staff attend frequent training and are keen to explore and initiate different types



of curricula to help provide a positive impact on children's development. For instance, they have researched the variety of ways children learn in other countries.

- Children develop a good understanding of routines and know when it is time to sit down for snacks and meals. However, these routines are sometimes prolonged meaning children become restless while waiting to eat.
- Older babies have good understanding. Staff encourage them to find and touch their nose, eyes, ears, mouth and tummy, which they do successfully. Toddlers repeat refrains from stories and songs, supporting good language skills. Preschool children build a large-scale puzzle together, talking about the different animals they see from around the world.
- Hygiene practices are good. Staff disinfect equipment and surfaces throughout the day to reduce the risk of germs and the transmission of the COVID-19 virus. They wear disposable gloves and aprons when preparing snacks and meals, including when they change children's nappies and when supporting them through toileting.
- Children have strong opportunities to be active and develop a good understanding of what constitutes to a healthy lifestyle. On-site chefs prepare hot nutritious meals that cater for all children's dietary and medical requirements. Free-flow access for children to the outside area encourages children to crawl, run, jump and climb to support their overall physical skills.

### **Safeguarding**

The arrangements for safeguarding are effective.

Management and staff have a good understanding in their role and responsibilities in protecting children from harm. They are alert to potential signs when a child's welfare is in danger and are confident to report these to relevant safeguarding partners. Management check staff's ongoing suitability to ensure they continue to be safe to work with children. Staff help children to learn how to manage risks. For instance, they talk to children about 'scissor safety' and how to keep the blade pointing down towards the item they are cutting.

## What does the setting need to do to improve?

To further improve the quality of the early years provision, the provider should:

- develop procedures to fully embed the key-person system to enable all children, particularly babies, to settle quickly
- review the organisation of daily routines to ensure all children remain engaged.

### Information about this early years setting

Owlets registered in 2019 and is located in Exeter, Devon. The nursery is open Monday to Friday, from 8am to 6pm, for 50 weeks of the year, closing over the Christmas period in line with Exeter College's academic year. It provides free early education funding for children aged two, three and four years old. There are 43 members of staff, most of whom hold relevant childcare qualifications from level 2 to level 7.

#### **Inspection activities**

- This was the first routine inspection the nursery received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the setting.
- The inspector and the manager carried out a learning walk together to discuss the intentions for children's learning.
- Children spoke to the inspector about what they enjoy doing when at the nursery.
- The manager and the inspector carried out a joint observation in the pre-school room.
- Written statements from parents were looked at and taken into account.
- The inspector looked at relevant documentation, including staff suitability and their qualifications.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
