Information about this children's home

The home is owned and run by a private organisation. It provides care for up to six children. According to the home's statement of purpose, it caters for children who require therapeutic care and support.

The home has been without a registered manager since May 2019.

Inspection date: 25 November 2021

This monitoring visit

This visit was undertaken to address specific concerns or allegations received by Ofsted.

Inspectors found that the home has not been regularly cleaned and that common areas were cluttered and poorly organised. Damage to walls, doors and windows had not been repaired. The children's bedrooms had not been regularly cleaned and several were lacking any sense of order. The children had been allowed to extensively write and draw on their bedroom walls and the outsides of their doors. The home bears little likeness to a family home.

Since the last inspection, there has been an escalation in incidents of aggression and violence in the home and damage to property. On several occasions, the staff have called police for assistance to maintain order in the home. At times, children have said that they feel unsafe in the home.

Inspectors also found that all the required procedures for recruiting new staff are not being followed, leaving the children at possible risk of harm.

Leaders and managers have expressed their intention to urgently address the identified shortfalls and failures and Ofsted will continue to monitor the running of the home and the well-being of the children.

the individual is mentally and physically fit for the purposes of the work that the individual is to perform; and

full and satisfactory information is available in relation to the individual in respect of each of the matters in Schedule 2. (Regulation 32 (1) (2)(a)(b) (3)(a)(b)(c)(d))
