The provider states in their statement of purpose that they provide care for up to two children with social and emotional difficulties.

The registered manager resigned in July 2021. A suitably experienced manager has been appointed and is in the process of submitting her application to Ofsted for registration.

# This inspection

### The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At this interim inspection, Ofsted judged that it has improved effectiveness.

Since the last inspection, there has been a change of manager and the appointment of a new staff team. The home has been refurbished and now offers a comfortable and homely environment. However, two windows are fitted with restrictors that are institutional in appearance. This detracts from the otherwise homely environment.

One child has moved to the home. She reports that she feels safe living at the home and can speak to all staff members if she feels upset or worried. The staff confidently use the home's safeguarding procedures if necessary and know what to do if the child goes missing.

The child met the staff, enjoyed a visit to the home and stayed for one night at the home before moving in, which has helped her to settle quickly. Her family has visited the home and she has personalised her bedroom, giving her a sense of belonging.

Routines in the home run smoothly and the child has a comprehensive placement plan in place. The staff support the child effectively to attend school. Previously, the child was often refusing to go to school. However, since arriving at the home she has a very good level of attendance.

The child's health needs are met in the home. She eats healthy and nutritious meals with the staff at the dining room table. The manager is ensuring that the child's emotional needs are met through the nurturing care from the staff and consultation with healthcare professionals when needed.

The quality of care provided in the home is comprehensively monitored through regular visits to the home by an independent person and through rigorous management oversight. A comprehensive development plan for the home is in place. This details how the further improvements that have been planned will be carried out within specific timescales. All requirements from the previous inspection are met.
