This home is a subsidiary of a large national organisation. The home provides care for up to three children. The provider states in its statement of purpose that it will meet the needs of children with a diagnosis of autism spectrum disorder.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At this interim inspection, Ofsted judged that it has sustained effectiveness.

Two children continue to live in the home. Both attend education and they enjoy a range of activities that support their interests. Memory books have been started for the children, which include photos and memorabilia that are collated in a meaningful way. Managers should ensure these continue to be updated so that children are supported to record their life experiences.

Care planning for the children is informed by partner agencies and professionals. This has supported staff to communicate effectively with one child in line with his specific needs. For example, a social story has been created and shared with him. This has helped the child to take on board important messages from staff. For another child, the registered manager has requested additional support from agencies due to an escalation of behaviours not previously seen. This joined-up approach aims to strengthen the child's care and support placement stability.

Children have been supported to build positive relationships with staff. As a result, there has been a reduction in incidents since the last inspection. However, the incidents that have occurred have been significant. Despite leaders and managers responding promptly and effectively to safeguard children after incidents have occurred, children have experienced harmful situations and staff have been injured during times when staff have found children's behaviour difficult to manage.

Plans have been updated by the registered manager. These provide clear guidance to support staff in their responses to children. However, training and development identified by managers is yet to progress to ensure that a skilled and consistent approach is embedded across practice. Feedback obtained during this inspection indicates that staff do not always know what is expected of them. As a result, responses to children can be inconsistent.

Records do not consistently evidence robust management oversight. For instance, a clear evaluation and analysis of incidents and the strategies used to respond to children is not always recorded. While frequency of supervision has increased, there is considerable variation in the quality of supervision recorded. This means that future learning to improve practice is limited.

Managers described 'a turbulent time' for the home since the last inspection. However, leaders and staff are confident in the registered manager's ability to lead the home. Managers are aware of the home's strengths and the shortfalls to be addressed so that care provided to the children is improved. A period to implement and embed plans for change is now needed.



Following this inspection, a repeated requirement under the leadership and management standard is made.
