Monitoring visit

Information about this children's home

This is a privately owned children's home with a school on the same site. The inspectors only inspected the social care provision at this school.

The home is owned and operated by a private organisation. It is registered to accommodate up to 54 children aged between nine and 17 years. The current occupancy is 26. Children are usually experiencing social, emotional and behavioural difficulties and they may have additional needs.

This monitoring visit

This monitoring visit was carried out in order to review a restriction notice that was served on 12 October 2021. The notice prevented additional children moving into the home until safeguarding and management arrangements had been improved.

Although managers and staff have taken steps to improve the home, there continue to be shortfalls in practice that have the potential to have an impact on the safety of children. As a result, the restriction on new admissions has been extended.

There continue to be weaknesses in risk management systems. Managers are not proactive enough in identifying and addressing risk. This means that some potential hazards have not been addressed. For example, a long-standing practice of children occasionally being allowed to sleep in each other's rooms, 'sleep overs', has not been reviewed to ensure that it remains appropriate for current residents. In one case, a child who required one-to-one staff supervision took part in an unsupervised 'sleep over'.

Staff believe that children have smoked drugs during two recent 'sleep overs'. Staff took appropriate action by ending the 'sleep overs' on both occasions. However, there is no evidence that staff have attempted to locate the cannabis or identify the source of the cannabis. For example, no room search took place. In addition, staff



did not consult with external agencies to identify whether the children required any additional guidance or support to reduce drug use.

Potential hazards within the grounds have not yet been made safe. Managers have made plans to minimise potential risks in the grounds, but most have not yet been implemented. Managers monitor the grounds on a weekly basis but have not identified or addressed some hazards.

There continue to be incidents of physical violence between children. Children say that there are fewer violent incidents now and that they feel safer as a result. However, they also say that they still feel vulnerable at times. For example, one child talked about a risk of violence if he did not adhere to unwritten rules imposed by other children.

Staff now keep clear records of any violent incidents but have not logged these as potential bullying incidents. This has the potential to hinder the monitoring of bullying and may mean that staff are not able to identify patterns of behaviour that place children at risk.

Spot checks on mobile devices are now being recorded. This helps to keep children safe from exploitation and online bullying.

Requirements and recommendations from the last inspection were not reviewed during this visit unless they were pertinent to the restriction notice. Therefore, a recommendation made at the last inspection has been repeated.

helps children aspire to fulfil their potential; and	
promotes their welfare.	
In particular, the standard in paragraph (1) requires the registered person to—	
lead and manage the home in a way that is consistent with the approach and ethos, and delivers the outcomes, set out in the home's statement of purpose;	
demonstrate that practice in the home is informed and improved by taking into account and acting on—	
feedback on the experiences of children, including complaints received; and	
use monitoring and review systems to make continuous improvements in the quality of care provided in the home. (Regulation 13 (1)(a)(b) (2)(a)(g)(ii)(h))	
In particular, this relates to management oversight of health and safety systems and safeguarding processes.	

Recommendation

The registered person should ensure that children are helped to explore their cultural identity. ('Guide to the children's homes regulations, including the quality standards', page 17, paragraph 3.22)
