Summary of key findings

This provision meets requirements

- The provider, who is also the manager, ensures that the premises are safe and secure. She gathers permission from parents about persons authorised to collect their child. This helps to keep children safe.
- The manager implements an effective child protection policy and procedure. Training is provided to all staff to help them fully understand this. All staff demonstrate that they have an up-to-date knowledge of safeguarding issues and know how to report concerns to other agencies to safeguard children.
- The manager demonstrates how she follows a robust recruitment procedure. She obtains required checks to enable her to make decisions about staff's suitability in order to safeguard children. The manager provides all staff with ongoing training and supervision opportunities, which promote the interests of all children.
- The manager is alert to safeguarding risks associated with the use of technology. A suitable procedure is in place to ensure the safe use of mobile phones and cameras. The manager has measures in place to monitor and restrict content that children can access when using technology equipment in the setting. This helps children to learn about keeping safe online.
- The manager is able to explain how she organises staffing to meet the needs of the children. She has reviewed the areas used by children to ensure staff are deployed effectively, to enable them to supervise children and keep them safe.
- All staff working with children hold a current paediatric first-aid certificate. Staff and managers understand the procedures to follow to manage, record and report any accidents or injuries that children sustain.
- The manager ensures that required information and records are organised and accessible to promote the safe and efficient management of the setting. Accurate records of children's hours of attendance are maintained. The manager demonstrates an understanding of the impact of this on children's safety.
- Through discussion, the manager demonstrates how children's behaviour is successfully managed. She explains how children are supported to understand the rules and boundaries in place at the setting, so that they understand her expectations.
- The manager explains how she ensures that children are provided with appropriate activities and experiences to complement their learning.
- The manager demonstrates an understanding of the importance of building positive relationships with parents to meet the individual needs of the children who attend.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
