Information about this children's home

The home is owned and operated by a private company and offers short- to medium-term placements for up to six children aged from 11 to 17 years. The children may have experienced trauma and exploitation, and may also have emotional and/or social difficulties.

Two managers have been appointed and have left the home since the last full inspection.

Due to COVID-19, at the request of the Secretary of State, we suspended all routine inspections of social care providers carried out under the social care common inspection framework (SCCIF) on 17 March 2020. We returned to routine SCCIF inspections on 12 April 2021.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has declined in effectiveness.

There have been five admissions since the last inspection. Two of the five children have moved on from the home as their needs could not be met safely, which led to notice being served by the manager and the responsible individual. One child had the offer of placement revoked before they arrived.

Three out of the four children living at the home at present are engaging with their care plans. These children speak positively about the staff and the care that they receive. They feel safe and can identify the staff they could speak to if they had any worries. The fourth child has been missing from home for a number of days. Staff have worked in partnership to safeguard him and have agreed a plan to collect him when located.

All the children at the home now have education plans which are underpinned by personal education plans and education and/or healthcare plans. Children were seen engaging in education during the inspection with a home tutor. Professionals spoken to confirmed that the children are engaging in education which meets their educational developemental needs and that staff are supporting their education within the home.

The home environment has much improved. The children are supported in personalising their bedrooms, which makes them feel valued. However, there are areas where the home could be improved to ensure that the children experience a safe and homely environment. For example, the games room is not fully set up and children have excessive belongings on the floor in their bedrooms.

Staff have supported children in registering with universal services. As a result, children's health needs are now being met and there is now effective partnership working with key professionals and families.

Progress for children at the home is variable. For some children, progress has not been made in relation to their needs being met. This has led to bullying, allegations against staff and assaults on staff. There is not always a consistent approach from staff to behaviour management. This, along with the impact of the COVID-19 pandemic, has led to the children not feeling that their care needs have been consistently met.

Allegations against staff have been managed effectively by the operational manager and responsible individual. Staff are subject to investigations to ensure that children are safe.



Some children are developing their independent living skills and are accessing vocational education. However, their progress in developing independent skills has not always been tracked and monitored. This means that children's progression records are not reflected in their care and pathway plans accurately, and children do not have evidence on file of their achievments.

Staff are motivated to engage the children in positive routines and activities to support their development. As a result, some children have benefited from forming positive relationships with the staff.

The home has not had a registered manager for over a year, which has impacted on the progress of the home's action plan from the last inspection. There have been some improvements implemented by the operational manager and the responsible individual; however, they are still developing effective oversight of the home.

Evidence of team meetings, supervison and training was not shared. This does not assure the regaultor that staff practice is sufficient to meet the needs of the children.

The operational manager and responsible individual are aware of the shortfalls and areas for improvement. They have recently appointed a new manager and new staff for the home, and they have improved the induction and training which staff will receive.

Since the last inspection, not all the requirements have been met. These relate to six-monthly reviews of the quality of care; the location risk assessment; the home's statement of purpose; and providing staff with regular supervision. This has impacted on the outcomes for children.

In order to complete a quality of care review the registered person must establish and maintain a system for monitoring, reviewing and evaluating—	
the feedback and opinions of children about the children's home, its facilities and the quality of care they receive in it; and	
any actions that the registered person considers necessary in order to improve or maintain the quality of care provided for children. (Regulation 45 (1) $(2)(b)(c)$)	
In particular, the registered manager must ensure that the children are regularly consulted and that their views, opinions and any action taken to improve the quality of care at the home are included in the quality of care review.

Recommendations

- The registered person should ensure that the home is a nurturing and supportive environment that meets the needs of the children. Children's homes will, in most cases, be homely, domestic environments. This particularly refers to the manager ensuring that the outside of the property is maintained to a high standard, including the rear porch, to enhance the living experience of the children. ('Guide to the children's homes regulations including the quality standards', page 15, paragraph 3.9)
- The registered person should actively seek independent scrutiny of the home and make best use of the information from internal monitoring, under regulation 45, to ensure continuous improvement. In particular, the registered manager must ensure that they gather the views of parents, social workers, health and education professionals and any other people who are significant in the children's



lives. ('Guide to the children's homes regulations including the quality standards', page 55, paragraph 10.24)

■ The registered person should ensure that a record of supervision is kept for staff. The record should provide evidence that supervision is being delivered in line with regulation 33 (4)(b). This particularly refers to the manager ensuring that all staff are supervised in line with the supervision policy. ('Guide to the children's homes regulations including the quality standards', page 61, paragraph 13.3)

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.

Inspectors have looked closely at the experiences and progress of children and young people, using the 'Social care common inspection framework'.
