Summary of key findings

This provision meets requirements

- The provider, who is also the manager, ensures staff understand the importance of keeping children safe and responding promptly to any concerns about a child's welfare. Staff are able to identify signs of potential abuse or neglect and know how to share any concerns to keep children safe.
- Staff understand how to provide a safe and secure environment for children. They know it is important to minimise risks and supervise children appropriately.
- The provider understands the importance of building strong partnerships with parents and staff at schools children also attend. She knows this is important to ensure continuity of care for children and to ensure children's individual needs can be met.
- Staff demonstrate they can provide a range of fun activities, suitable for children before or after a day at school. For example, staff know that some children will want to play energetically, and others will need to rest or play quietly. Staff show they can provide a range of resources that will meet the differing needs of children and that children will enjoy.
- Staff understand the importance of building warm relationships with children, so that children feel welcome and valued. Staff understand this helps ensure high levels of well-being.
- The provider knows how to promote children's good health. She understands the importance of providing healthy and nutritious snacks and teaching children the importance of following robust hygiene routines.
- The provider knows it is important to support children to be tolerant and respectful of the similarities and differences between themselves and others. She understands the benefits of children learning about their own and other cultures.
- The provider values her team. She knows how to make staff feel appreciated.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
