Monitoring visit

Inspected under the social care common inspection framework

Information about this children's home

The home is owned and run by a private organisation and can accommodate and care for up to three children with social and emotional difficulties. According to its statement of purpose, the home is 'for young people and children with individualised needs who may benefit from living in a smaller home that supports their needs'.

The manager has been registered with Ofsted since April 2021.

This monitoring visit

A full inspection conducted on 10 and 11 January 2022 judged the home inadequate due to serious shortfalls in respect of staff recruitment, risk management and poor monitoring oversight. As a result of that inspection, senior leaders gave assurances that only safely recruited staff would be working at the home with immediate effect.

This monitoring visit did not consider all requirements that were made from the full inspection, because the dates for completion had not yet passed. These requirements remain. However, due to the serious concerns in respect of poor staff recruitment practice and monitoring oversight, this monitoring visit was conducted to seek assurance about the immediate and current safety of the children.

The inspector reviewed some of the staff recruitment files against the names of staff as detailed on the current staffing rota. Shortfalls and gaps found in those recruitment files included examples of incomplete employment histories, the absence of necessary references, and some references not being verified. One specific example included the absence of an overseas check for a member of staff who has worked abroad. Other examples included the failure to check and verify staff's Disclosure and Barring Service (DBS) checks. One member of staff's DBS check, that contains a caution, has not been suitably risk assessed to determine this person's

suitability to work with children. These shortfalls raise significant concerns about the continuing poor recruitment practice of the provider and its failure to provide effective safeguards through safer recruitment. Consequently, and in light of these additional findings, Ofsted does not have confidence in the provider's ability to protect children from potentially unsafe and unsuitable adults.

Incidents since the full inspection have not been consistently well managed. One example includes a child informing the staff that she was distressed and engaging in self-harm. The staff member's record indicates that regular checks were conducted on this child throughout the night. However, the record of a different staff member's conversation with the child describes the child as saying that no checks were made on her during that same evening. Managers were unable to demonstrate that these discrepancies had been identified or further explored through management monitoring.

Another example included confusion among the staff team as to the whereabouts of razor blades that should have been stored in a safe in the staff office. This confusion resulted in a staff member asking a child with known self-harm risks if the child had these items in their possession. Although it was later discovered that a different staff member had disposed of the razor blades, it is of significant concern that there was any confusion as to the whereabouts of such dangerous items when the risk of self-harm at the home is high.

Following the shortfalls previously identified in respect of the staff's use of inappropriate and punitive responses to a child's behaviour, the registered manager has begun to review these examples with the child and the staff team. Further training for the staff is planned, albeit not yet started

Overall, Ofsted remains concerned that significant shortfalls and omissions are continuing in relation to safer recruitment. The provider has failed to use protective measures to protect the children from potentially unsafe adults. When combined with the failure to make sufficient progress to monitor effectively the experiences of the children, the regulator is not reassured that children are being safely cared for. Ofsted has therefore, suspended the home's registration.
