Summary of key findings

This provision does not meet requirements

- Children's safety and welfare is compromised because the childminder does not monitor the quality of her provision well enough. This means a number of legal requirements are not met.
- The childminder has failed to notify Ofsted of several significant events since her last inspection. This includes new household members, a change to the childminder's health and the use of an existing household member as her assistant. These failures to notify Ofsted of significant events means that Ofsted have not been able to complete required suitability checks.
- The childminder has not fully addressed the action set at the last inspection. As a result, required documentation, including a record of the hours that children are in the care of the childminder, is not maintained. Written policies are not available for inspection and are not shared with parents.
- The childminder has updated her first-aid training. However, there have been times when she has left minded children in the care of someone who does not hold a paediatric first-aid certificate, for example, when children are collected from school. This places children at risk should first-aid treatment be required. This also means that there are times when children are not within sight or hearing of the childminder. During the inspection, the childminder confirmed she understood that this put the children at risk and she would ensure that she was always present when children are being cared for.
- The childminder does not have a sufficient knowledge and understanding of child protection issues or the procedures to follow if she has concerns about a child's welfare. Additionally, she is unsure of the procedure to follow in the event of an allegation being made against herself or a member of the household.
- The childminder's knowledge of the learning and development requirements is limited. She comments that it is a long time since she has cared for any children in the early years age range. The childminder is unable to demonstrate how she would implement each area of learning to fully support children's learning and development.
- Through discussion, the childminder demonstrates that she provides an inclusive service and that she would never treat any child less well than another because of their race, religion, home language, family background, gender or special educational needs and/or disabilities.
- Through discussion and during a tour of the premises, the childminder demonstrated that she is able to affectively identify and take steps to minimise potential hazards. This helps to keep children safe within her home.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

The provision is not meeting requirements and Ofsted intends to take enforcement action.

- The childminder showed the inspector the premises and explained her risk assessment.
- The inspector questioned the childminder to establish her knowledge and understanding of her safeguarding responsibilities.
- The inspector held discussions with the childminder about how she would meet the care and learning needs of children.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
