## Summary of key findings

#### This provision does not meet requirements

- The childminder demonstrates that she is alert to the possible indicators of abuse. However, she is not aware of the procedure to follow in the event of an allegation being made against herself or a household member.
- Since her previous inspection, the childminder has updated her paediatric firstaid training. This helps to ensure that she can competently administer first-aid treatment to children in an emergency.
- The childminder completes risk assessments and takes steps to minimise potential hazards. These measures will help to keep children safe.
- The childminder demonstrates that she can offer a welcoming and inclusive service. She states that she would never treat any child less well than another because of their race, religion, home language, family background, gender or special educational needs and/or disabilities. The childminder has reviewed and updated resources and images to make these more diverse.
- The childminder understands the importance of promoting a healthy lifestyle. For example, she intends to provide lots of opportunities for children to be physically active in the fresh air and will offer healthy snacks.
- The childminder understands the importance of monitoring children's progress and her role in helping to ensure children are well prepared for school.
- The childminder has access to a wide range of resources and play materials. She intends to use these appropriately to help children of differing ages and abilities make progress in their learning and development.
- The childminder has a positive attitude to working in partnership with parents. She has relevant documents that she will share with parents to show that she is committed to collaborative working. The childminder is aware of the importance of promoting children's well-being and learning from when they first start to attend.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the provider.
- The childminder showed the inspector the premises, the available play materials and explained her risk assessment.
- The inspector questioned the childminder to establish her knowledge and understanding of her safeguarding responsibilities.
- The inspector held discussions with the childminder about how she would meet the care and learning needs of children.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
