Summary of key findings

This provision meets requirements

- The manager provides an inclusive environment, with a range of stimulating activities both indoors and outdoors. She explains how staff regularly seek children's views and provides them with resources that they know they will enjoy.
- The manager knows how to manage children's behaviour in a supportive way. She discusses how staff incorporate sharing, turn taking and an understanding of including others into activities. The manager understands the benefit of giving children opportunities to talk about their experiences, such as during snack time.
- The manager explains how she keeps her staff up to date with changes in legislation. She and her staff complete online training courses and personal research to help build on their skills and knowledge.
- The manager and staff understand how to encourage children to be healthy. They provide children with healthy food choices and give them clear guidance on why exercise is important to help them stay fit and well.
- The manager discusses how she uses information from staff and children to identify improvements. She recognises the importance of working in partnership with parents and other professionals, to keep them informed about changes or issues affecting children.
- The manager has a secure knowledge of child protection. She understands the procedures to follow should she have a concern about the welfare of a child. The manager ensures all staff receive regular safeguarding training. The premises are safe and suitable and detailed risk assessments are undertaken of any activities taken outdoors to ensure children are safe.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Netley Marsh Before and After School Club registered in 2011. It operates from Netley Marsh C of E School in Woodlands, near Southampton, Hampshire. The club is open Monday to Friday, during term time only, from 7.45am to 8.45pm and 3.15pm to 6pm. There are three members of staff who work with the children. Of these, one holds an early years qualification at level 6 and one holds a level 3 qualification.

Inspection activities

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the setting and has taken this into account in their evaluation of the provision.

- The inspector looked at relevant documentation, including paediatric first-aid qualifications and the suitability of staff.
- The inspector spoke to the provider at appropriate times during the inspection.
