Information about this children's home

This is a privately owned children's home that provides care for a maximum of three children. The home cares for children who may have emotional and/or behavioural difficulties or learning disabilities.

The recently appointed home's manager has applied to be registered.

Due to COVID-19, at the request of the Secretary of State, we suspended routine inspections of social care providers carried out under the social care common inspection framework (SCCIF) on 17 March 2020. We returned to routine SCCIF inspections on 12 April 2021.

We last visited this setting 27 April 2021 to carry out a full inspection. The report is published on the Ofsted website.

This inspection was carried out following a requires improvement to be good judgement at the last inspection.

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has sustained effectiveness.

Since the last inspection, a new manager has been appointed. He is currently going through the registration process. The manager has created a supportive, nurturing, happy home where children are loved, and staff are valued. As a result, staff stability has been maintained since the last full inspection, and children say that they like living at the home.

Staff feel fully supported and enjoy their work. Staff share the ethos and vision of the manager, and they are highly motivated. One staff member said, 'The manager has completely turned the home around from what it was previously. We now have a clear picture of where we are going as a home and what our end goals are.'

The manager is reflective, thoughtful and seeks to improve his practice. There is a willingness to accept that things may not work, but also a real desire to get it right for children. As a result, children are receiving care that meets their current and emerging needs.

Risk assessments are of good quality. These assessments and plans provide detailed guidance to staff on how to manage risks safely and effectively. They incorporate the therapeutic approach of the home, and this runs through these documents.

The home is generally welcoming and comfortable. However, the COVID-19 pandemic contributed to a delay in some maintenance work being completed in the home. The environment has started to improve; however, there are still a number of outstanding maintenance issues that require completion.

Leaders and managers have failed to make suitable arrangements to ensure that all staff have had specific training to meet the needs of children prior to them coming to live in the home. One child, who recently moved into the home, is on the autism spectrum, but specific training for staff has not yet been delivered. A plan is now in place to rectify this, with training scheduled very soon.

Incidents and allegations have been appropriately reported to placing local authorities, the designated officer for the local authority and Ofsted. Managers maintain detailed chronologies and have proactively followed up any delay in information-sharing by agencies. Managers undertake lessons-learned exercises where appropriate. As a result, there have been changes to policies and procedures and improved practice.



There is improved evaluation of any incidents, including the use of physical intervention. Managers provide staff with opportunities to reflect on their practice and their responses to incidents. As a result, there has been a reduction in incidents.

Leaders and managers have worked to change the culture of the home, moving to a therapeutic approach, and supporting children to learn through natural consequences rather than sanctions. There is now a high emphasis on recognising and rewarding positive behaviour. Children are responding well to this new approach.
