#### Information about this children's home

The home is owned and operated by a private organisation and can provide care for up to five children with social and emotional difficulties.

There has been no registered manager since October 2021.

## This monitoring visit

The purpose of this monitoring visit was to assess the provider's progress in meeting the compliance notice issued under regulation 13, the leadership and management standard, and monitor compliance with the suspension notice in place.

The provider has undertaken a review of the internal monitoring systems used at the home. The provider's review was in-depth and has enabled senior leaders to plan how to support any shortfalls in management capacity and strengthen the leadership team response to ensure consistent day-to-day management and oversight of the home.

A comprehensive review of risk management systems was undertaken. The review highlighted several missed opportunities, including within the provider's own monitoring systems, to identify significant failings in the monitoring and oversight by the responsible individual. This review has led to internal changes to monitoring systems to prevent future occurrence.

A review of safer recruitment practice has taken place. The inspector found that some files are still currently being vetted to enable staff to return to work. However, the inspector found evidence, in new systems put in place to enable safer recruitment, of an improved understanding and approach to ensuring that staff are suitably vetted to work with children.

Supervision practice continues to improve following the implementation of a new system. Records reviewed show that staff are benefiting from regular, supportive supervision with the additional opportunity to reflect on past events and identify any learning and development needs.

As a result, Ofsted's decision is that the compliance notice has been met.

The property has undergone extensive maintenance and redecoration. However, some concerns remain regarding fire safety and risks posed to children from the continuing unfinished works.

The provider has continued to comply with the suspension notice. No children have lived at the home since the suspension notice was served. Senior leaders have confirmed that they are not in a position to move children into the home as they do not yet have a manager appointed and the recruitment of residential care workers is still underway.

Consequently, there is insufficient leadership in place to remove the current suspension notice. Furthermore, the provider has not recruited sufficient staff to be able to adequately or safely provide care to children should the current suspension notice be lifted and children readmitted to the home. Therefore, Ofsted's only option is to reissue the suspension notice for a further period.

Some progress has been made to meet requirements at the home. However, the remaining requirements were not looked at during this visit and have been repeated.

that the home's day-to-day care is arranged and delivered so as to keep each child safe and to protect each child effectively from harm; and	
that the premises used for the purposes of the home are designed, furnished and maintained so as to protect each child from avoidable hazards to the child's health. (Regulation 12 (1) (2)(a)(i)(ii)(iii)(v)(vi)(b)(d))
