Summary of key findings

This provision does not meet requirements

- The childminder does not have sufficient understanding of safeguarding issues and child protection procedures. She does not know how to correctly respond if an allegation is made against her or a household member. The childminder is unaware of the 'Prevent' duty guidance and her related responsibilities. She is unclear about the roles of relevant agencies.
- The childminder does not explain sufficiently well how she will plan and implement activities to help children make progress in their learning. The childminder does not demonstrate that she is able to address persistent gaps in children's learning if they arise. Despite this, the childminder recognises the importance of working closely with parents and other professionals.
- The childminder understands the importance of providing children with fresh air and exercise, daily. She is able to describe the activities that she would use in her community, such as visits to parks, to help children develop their physical skills. The childminder discussed the extended outings that she would organise, for example to the farm or museum.
- The childminder shares how she will help children to behave well and acquire positive social skills. She plans to help children to interact with others, for example, at local groups. The childminder explains how she will help children to share, take turns and achieve independent self-care.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

- The childminder showed the inspector around areas of her home that will be used by children and explained how she will manage risks.
- The inspector reviewed documents. These included relevant policies and evidence of the childminder's professional development.
- The childminder and inspector discussed educational programmes and safeguarding issues.
