Information about this children's home

The home is registered to provide care and accommodation for three children up to the age of 18 with emotional and/or behavioural needs. A private provider operates the home.

The registered manager is suitably experienced and is working towards the level 5 qualification in leadership and management.

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At this interim inspection, Ofsted judged that it has sustained effectiveness.

Three children lived at the home at the time of this inspection. Since the full inspection, one child has moved into the home and one child has left. The child who left moved on in a planned way with some good quality-work undertaken by staff to support her next steps to independence. The child who moved into the home has settled, after a well-considered admission process. Overall, children have a positive time while at the home.

Relationships between staff and children continue to be strong and positive. Permanent staff understand children's needs well and, overall, work hard to keep them safe. Risk assessments now include details of the actions staff will take to reduce identified risks. In addition, safeguarding matters are dealt with swiftly and information is shared appropriately with relevant agencies and children's families.

Despite this positive work, the manager has not ensured that a child's risk assessment includes information about overnight stays with a friend. This means staff do not have a clear plan to follow, including welfare checks and medication arrangements, when these visits take place.

One child has a learning disability and a behavioural diagnosis. Additionally, the statutory plans detail past trauma and possible post-traumatic stress disorder. Not all staff have undertaken training to understand this child's additional needs. This limits staff's understanding and ability to provide all the support they can to facilitate the child's progress and maintain their welfare.

The manager has some good monitoring systems to understand the quality of care provided to children. However, these are not yet effective in all areas. For example, recommendations raised in a fire risk assessment have not been addressed promptly. In additional, the manager was unable to locate one child's placement plan and could not confirm if all staff had read the latest plan for this child.

Children told the inspector that they like living at the home and feel safe. Staff talk through topics with children that are relevant to their care and safety. For example, staff discuss with the children the need to stay safe online and how children can do this. They also discuss issues such as exploitation and sexual health. These discussions reiterate important messages to the children to help them understand risk and how to reduce it.

Staff now receive regular and good-quality supervision. Children and staff speak positively about the support they receive from the manager.



Improvements have been made to the environment, with a remodelled garden and, inside the home, soft furnishings and some redecoration. There is a now a more homely feel to the environment, which children enjoy.

Working relationships with professionals and parents are good. Professionals speak positively about good communication and information-sharing between staff, the manager and themselves. As a result of good partnership working, children remain central to the care they receive.

New employees are subject to an assessment of their suitability to work with children. This includes references being taken up and criminal records checks. The provider asks staff to complete a self-declaration about previous disciplinary matters and prior convictions, but records regarding this are unclear.
