Summary of key findings

This provision does not meet requirements

- Although the childminder has recently accessed safeguarding training, she does not know how to recognise or respond fully to signs of possible abuse, such as female genital mutilation. Furthermore, the childminder does not have an understanding of the 'Prevent' duty guidance, to ensure that she effectively understands relevant requirements and her responsibilities to protect children.
- The childminder does not effectively evaluate her service to keep her knowledge current. She cannot explain how she intends to deliver a full and varied curriculum in all areas of learning. The childminder has poor knowledge of the areas of learning and how to assess children's progress, to meet the learning and development requirements.
- The childminder has recently accessed a 12-hour online paediatric first-aid course. Nevertheless, this does not meet requirements.
- The childminder understands how to support children's positive behaviour. For example, the childminder says she will talk calmly to children, encourage them to share toys and promote good manners.
- The childminder confirms she will provide a fully inclusive service. For instance, she intends to treat all children with equal respect, celebrate and value home experiences and develop children's appreciation of diversity within their local community.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

- The inspector discussed with the childminder the suitability of all those living on the premises.
