Monitoring visit

Inspected under the social care common inspection framework

Information about this children's home

This home is operated by a private provider. It is registered to provide care and accommodation for up to 10 children. At the time of the inspection, there were two children living in the home and one young adult.

The registered manager post is vacant. There has been a manager in place since September 2021 who has submitted her application to register with Ofsted.

This monitoring visit

This monitoring visit was completed following concerns that were identified by inspectors during a visit to the home to complete registration work.

During this visit, inspectors identified significant failings in safeguarding practice and significant shortfalls in management oversight. Leaders, the manager and staff do not respond appropriately to safeguarding incidents that occur, or ensure that there are effective strategies in place to safeguard the children living in the home. Therefore, the children living at the home have been placed at risk of significant harm.

There has not been a registered manager at the home since August 2020. The home was not being managed appropriately to ensure that children are safeguarded. The manager and staff had failed to provide basic care and support to a child around the condition of their bedroom and had allowed the child to live and go to sleep in neglectful conditions.

Physical intervention practice is not safely supporting children who are experiencing crisis in their lives. Restraint is used commonly as a behaviour management method by staff. Records of restraints are not clear about the measures that staff have used, or for how long children have been restrained. On one occasion, a child was held

face down on the ground by four members of staff. Poor management oversight means that staff practices are not challenged in a timely way to ensure that appropriate care and support is provided to children.

Leaders and managers are not consistently or effectively reviewing documentation relating to incidents and restraints. This does not ensure that restraint is only used as a last resort. Furthermore, records are not clear about the actions taken following incidents to ensure that children have not been harmed or about the emotional support offered to children.

There were no records of significant events for any of the children living in the home since November 2021. Staff are not keeping records appropriately. This is despite several significant events occurring, such as damage to property and an allegation about staff.

Leaders and managers had failed to challenge restrictive practices in the home, despite identifying that these were neither proportionate nor necessary. Children's access to food was restricted by locks on kitchen cupboards. Children did not have access to plates and cutlery, and were only permitted to use plastic plates, despite this not being an identified risk for all children.

Children were not being cared for by a consistent staff team. On occasions, there had been insufficient numbers of employed staff caring for children. During a five-week period, children were cared for by 17 different agency members of staff. This does not ensure continuity of care for children living in the home.

Risk assessments did not provide clear or effective strategies for the staff to follow. As a result, the manager and staff were failing to appropriately respond to and reduce the risks presented to the children.

Due to the serious safeguarding concerns, Ofsted took immediate action and suspended the registration of the home. Consequently, there are no children living at the home.

understand the roles and responsibilities in relation to protecting children that are assigned to them by the registered person;	
take effective action whenever there is a serious concern about a child's welfare; and	
that the home's day-to-day care is arranged and delivered so as to keep each child safe and to protect each child effectively from harm;	
that the premises used for the purposes of the home are designed, furnished and maintained so as to protect each child from avoidable hazards to the child's health. (Regulation 12 (1)(2)(a)(i)(iii)(v)(vi)(b)(d))	
Restraint in relation to a child is only permitted for the purpose of preventing—	17 February 2022
injury to any person (including the child);	



serious damage to the property of any person (including the child); or	
a child who is accommodated in a secure children's home from absconding from the home.	
Restraint in relation to a child must be necessary and proportionate. (Regulation 20 (1)(a)(b)(c)(2))

helps children aspire to fulfil their potential; and	
promotes their welfare.	
In particular, the standard in paragraph (1) requires the registered person to—	
lead and manage the home in a way that is consistent with the approach and ethos, and delivers the outcomes, set out in the home's statement of purpose;	
ensure that staff work as a team where appropriate;	
ensure that staff have the experience, qualifications and skills to meet the needs of each child;	
ensure that the home has sufficient staff to provide care for each child;	
ensure that the home's workforce provides continuity of care to each child;	
understand the impact that the quality of care provided in the home is having on the progress and experiences of each child and use this understanding to inform the development of the quality of care provided in the home;	
use monitoring and review systems to make continuous improvements in the quality of care provided in the home. (Regulation 13 $(1)(a)(b)(2)(a)(b)(c)(d)(e)(f)(h)$)	
The registered person must prepare and implement a policy ("the behaviour management policy") which sets out—	17 February 2022



how appropriate behaviour is to be promoted in the children's home; and

the measures of control, discipline and restraint which may be used in relation to children in the home.

The registered person must keep the behaviour management policy under review and, where appropriate, revise it.

The registered person must ensure that—

within 24 hours of the use of a measure of control, discipline or restraint in relation to a child in the home, a record is made which includes—

the name of the child;

details of the child's behaviour leading to the use of the measure;

the date, time and location of the use of the measure;

a description of the measure and its duration;

details of any methods used or steps taken to avoid the need to use the measure;

the name of the person who used the measure ("the user"), and of any other person present when the measure was used;

the effectiveness and any consequences of the use of the measure; and

a description of any injury to the child or any other person, and any medical treatment administered, as a result of the measure;

within 48 hours of the use of the measure, the registered person, or a person who is authorised by the registered person to do so ("the authorised person")—

has spoken to the user about the measure; and

has signed the record to confirm it is accurate; and



within 5 days of the use of the measure, the registered person or the authorised person adds to the record confirmation that they have spoken to the child about the	
measure. (Regulation 35 (1)(a)(b) (2)(3)(i)(ii)(iii)(iv)(v)(vi)(vii)(viii)(b)(i)(ii)(c))
