Summary of key findings

This provision meets requirements

- The childminder holds a valid paediatric first-aid certificate. She knows how to deal with children's minor accidents and incidents.
- The childminder intends to observe and monitor children's progress to help plan a broad curriculum. She will ensure that a variety of age-appropriate toys and resources are readily available to children.
- The childminder wants to promote children's healthy habits. For example, she aims to encourage children to play outdoors for fresh air and exercise.
- The childminder knows how to establish a working partnership with parents. This includes sharing information with parents to promote children's learning and good behaviour.
- The childminder is committed to keeping her skills and knowledge of early years up to date. She aims to evaluate the quality of the provision to benefit children and their parents.
- The childminder describes how she intends to promote an inclusive practice. This includes supporting children's individual cultural backgrounds and experiences.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the provision.
- The inspector toured the areas of the childminder's home that she intends to use for childminding purposes. She checked the toys and resources that will be made available to children.
- The inspector looked at required documentation, including first-aid certificate and suitability checks.
- The inspector talked to the childminder about learning and safeguarding requirements.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
