What is it like to attend this early years setting?

The provision is inadequate

The provider does not ensure that the manager and staff keep children safe. Children's safety and welfare are significantly compromised. Some staff roughly handle children and pull them by their arms. This puts children at risk of injury. Staff fail to identify and minimise risks to children at mealtimes. This puts children at the risk of choking. Babies' safety is not always assured when they play outdoors.

Teaching is variable. Although younger children receive better educational opportunities, older children have a very poor learning experience. This significantly hinders the progress they make. Furthermore, staff do not support them to learn how to manage their own feelings and behaviour. This significantly impacts on children's emotional security and hinders them from forming trusting bonds with staff. Some staff have a poor knowledge of how children learn and fail to build on what they know and can do. During large group times, children show patience and sit with staff for twenty minutes. However, teaching is repetitive and staff do not help children to gain new knowledge.

Younger children enjoy sharing books with staff. They confidently role play the scenes from familiar stories, such as pretending they are a wolf and blowing down the pig's houses. They are curious and keen to explore. For example, they ask questions to deepen their understanding about a pine cone and notice that they have a shadow. Babies are well motivated to build their physical strength and confidently pull themselves up to stand.

What does the early years setting do well and what does it need to do better?

- The provider fails to ensure that the manager and staff have a clear understanding of their roles and responsibilities. The manager has been unsuccessful in sustaining improvements which were made, following actions that were previously raised. This has had a significantly negative impact on children's experiences at the nursery regarding their welfare and learning.
- The manager has failed to identify and address weaknesses in staff practice, particularly relating to children's educational experiences and emotional security. The manager does not support staff to provide an effective curriculum that positively helps children to manage their feelings and behaviour. Staff do not appropriately help children to learn what is expected and how to successfully adjust their behaviour. Staff are not positive role models and resort to manually handling children when they do not comply with a request, such as to wash their hands or to sit down on the carpet. Staff grab children by the arms and move them to where they want them to be. This puts children at risk of injury and emotional harm.



- The manager and staff have completed some training. However, insufficient focus has been placed on improving staff knowledge and the quality of teaching. The manager fails to provide new staff with an effective induction to ensure they understand the nursery policies, such as the use of physical intervention.
- Staff observe children and assess the progress they make. Staff working with younger children, suitably use this information to plan for their learning. This includes providing effective targeted support for children with special educational needs and/or disabilities. However, staff working with older children do not use their knowledge of children's achievements to plan activities that consistently meet their learning needs. During large-group activities, staff do not match their teaching to children's various stages of development. For example, they tell older children who have limited language, the letters from their names and ask them to repeat these back. This does not support their learning well and puts them under unnecessary pressure.
- Staff fail to promote the health and welfare of children. They give young children food that is not safe for them to eat and can present a choking risk. This compromises children's safety.
- An effective key-person system is in place. The manager and staff have a sound working partnership with parents. They have daily communication with parents to keep them informed about their child's day.
- Staff support younger children's communication and language skills effectively. For example, babies and young children without language, respond well to visual prompts and signs. They know that a ball means it is time to get ready to go outdoors.

Safeguarding

The arrangements for safeguarding are not effective.

The provider fails to ensure that the manager and staff identify and eliminate hazards to children. Risk assessment at the nursery is poor. Staff take babies to play in gravelled areas and allow them to play with small stones. This puts them at risk of choking and serious harm. Staff do not know how to safely prepare food for children. They do not recognise that whole dried apricots and circles of carrots are a potential choking hazard for young children. The manager and staff know some signs that may indicate that a child is at risk of abuse or neglect and how to report any concerns. However, they have failed to identify inappropriate behaviour displayed by some members of staff relating to the use of physical intervention and rough handling of children.

What does the setting need to do to improve?

The provision is inadequate and Ofsted intends to take enforcement action.

Victoria House Neighbourhood Nursery registered in 2004. It operates in Smethwick, West Midlands. The nursery employs 21 members of childcare staff. Of these, 19 hold early years qualifications from level 3 to level 6. The nursery is open Monday to Friday, from 7.30am to 6.15pm all year round, except for bank holidays. The nursery receives funding to provide free early education to two-, three- and four-years-old children.
