## **Summary of key findings**

#### This provision meets requirements

- The provider is able to describe the enjoyable and inclusive activities that staff would plan for children. The provider explains how important information would be appropriately shared with school staff and parents to promote a consistent approach for children.
- The provider reviews his policies to take account of safer recruitment guidance. He shares how the initial and ongoing suitability of staff would be assessed. The provider explains how he would provide staff with regular support and training to help them carry out their roles and responsibilities.
- The provider recognises the importance of implementing effective behaviour strategies. He describes how children would receive support to listen to instructions and understand what is expected. He shares how staff would help children to further develop their social skills and to express how they feel in positive ways.
- The provider understands how to correctly respond if he suspects that a child is at risk of abuse or harm, or if an allegation is made. He knows how to work with relevant agencies to get children and families the support that they need. The provider is alert to potential risks to children, such as exposure to unsafe technology or extreme views. He explains how risks will be managed to help keep children safe.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
