Summary of key findings

This provision meets requirements

- The childminder has a clear understanding of how to safeguard children, including how to seek advice and support should she have a concern. She has made good use of training to keep her knowledge of current safeguarding issues up to date.
- The childminder demonstrates how she provides enjoyable activities to help promote children's ongoing learning and development. She is aware of how to use her garden and plan outings for children to explore the world around them and develop a range of physical skills.
- The childminder understands how to provide a broad range of activities and resources for children of different ages and abilities. She has high expectations regarding children's behaviour. She knows how to manage their behaviour in a supportive way. She supports children with learning about sharing, turn taking and an understanding of others into daily activities.
- The childminder works closely with parents to gather information about children's interests. She uses this information to help plan a variety of experiences to support children's learning and well-being. She understands the need to share children's achievements and support the emotional well-being of children in her care.
- The childminder offers a welcoming environment for children. She has suitable procedures in place to support her in assessing her home for safety. In addition, she accesses relevant training, including for paediatric first aid. She knows the procedures she should follow to keep children safe.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken this into account in their evaluation of the provider.
- The childminder showed the inspector the premises and discussed how she ensures they are suitable for the care of children.
- The inspector sampled relevant documentation that the childminder uses when caring for children.
- The inspector checked the childminder's understanding of safeguarding procedures.
- The inspector held discussions with the childminder about how she intends to meet the requirements of the early years foundation stage.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
