What is it like to attend this early years setting?

The provision is inadequate

Children arrive happy at the nursery, however, they are not given opportunities to progress with their learning and development. Children have limited opportunities to explore and develop their imagination. They are told what they are doing by staff, and have their hands guided as they paint. Babies are restricted to sitting in highchairs throughout the session with extremely limited interactions and resources. Children's learning is hindered by the lack of appropriate questioning and activities for their stages of learning and understanding. Children's safety is also greatly compromised with how they are moved around the nursery by staff.

Children's health is compromised as they are not taught the importance of handwashing before eating. Children thoroughly enjoy playing outside, however, they are given limited access and time to extend these areas of their development and their interests. Children are not given the opportunity to move resources around the nursery to explore. For example, the effects of water and sand mixing. Children are denied activities when they ask for them, such as asking for water play when they are outside, as staff say they do not want to change them out of wet clothes. This further hinders children's learning and development.

What does the early years setting do well and what does it need to do better?

- The provider, who is also the nominated individual and acting manager, has failed to make progress since the last inspection. Although staff have first aid in place, all other actions have not been met. The provider lacks the ability to see any weak practices nor any areas for improvement. This is a significant cause for concern.
- The provider was unable to provide any credible evidence that she had notified Ofsted of changes to the management of the setting. This a breach of welfare requirements. This action was not met from the previous inspection. The provider demonstrated she was aware of notifying Ofsted, however, there was no evidence to show this had been carried out.
- Although the provider and staff have attended training it has not been effective. Staff still lack the knowledge and understanding of safeguarding and how to keep children safe. The provider has been given recommendations to improve by the local early years team, and she has failed to use any of this information to make improvements in the nursery. This calls into serious question the provider's ability to drive any form of improvement in the nursery.
- The provider does not follow safe staff recruitment procedures. The provider is unable to provide credible evidence that she checks the suitability of staff on their appointment to the nursery. Staff are left alone with children and change nappies, without appropriate checks in place. The provider also fails to carry out any other checks, such as references to see how they worked in other settings.



This puts children at risk of harm.

- The provider does not follow her own safeguarding policies, especially in regards to the use of mobile phones in the setting. The provider did not question the parent when she asked if she could keep her phone with her when she waited in the main nursery room. despite signs on the door stating no phones beyond that point. This calls into question the suitability of the provider and her knowledge of the welfare requirements.
- During mealtimes, the provider was handling food before giving it to children without washing her hands. Staff also failed to teach children the importance of learning how to protect themselves from cross-contamination and infection through handwashing procedures. In addition, staff called children greedy when they reached for more food during mealtimes. This does not promote healthy lifestyles and children's relationship with food.
- The provider and staff do not effectively support and teach children. Activities are overly ambitious for the children taking part and they are not able to learn from them. For example, staff keep asking children to count and sound out letter names, when children have limited speech. This sets children up to fail before they even start activities. This was an action at the last inspection, and the provider has failed to make any progress in this area.

Safeguarding

The arrangements for safeguarding are not effective.

Despite recent training, staff are still not aware of signs and symptoms of safeguarding and child protection, in particular the 'Prevent' duty and local safeguarding concerns. Leaders and staff are also not aware of the correct and safe ways to pick up and guide children around the nursery. They regularly lift babies in and out of highchairs by the tops of their arms, putting them at risk of serious injury. The provider does not carry out save staff recruitment. All of this puts children at significant risk of harm.

What does the setting need to do to improve?

The provision is inadequate and Ofsted intends to take enforcement action.

We will issue a Welfare Requirements Notice requiring the provider to:
