# The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At this interim inspection, Ofsted judges that it has improved effectiveness.

The one child living at the home is experiencing well-planned care from staff who are attentive and familiar with the child's needs. As a result, the child is making good progress. The child's social worker is very complimentary about how the child is learning to manage their emotions.

The planning for the child moving in was careful and thorough. The staff were involved in this process. This has resulted in the child settling quickly. Plans are current, clear and fit with the plans of the placing authority. The child's current areas of vulnerability have been identified and strategies to guide the staff to address these are clear.

The manager has completed a thorough and clear matching assessment of the child moving into the home. This process identified staff training needs which have been completed by most of the staff. However, there are some shortfalls in recording of the process that led to staff training and matching against the location of the premises.

Regular team meetings, supervision and a monthly reflective space provide staff space to discuss the child's needs and risk management. Staff spoke confidently about the training and support they receive. One staff member said, 'it is so much better and done differently than before'.

The manager is receiving regular support and supervision. There is a clear induction process that has been completed and demonstrates the guidance from the responsible individual. The manager also has the support of peers as well as the employment of an area manager to provide additional senior management oversight.

Recruitment records have been updated. The new and improved recording system supports a clear evidence trail of the manager's oversight of safer recruitment. There is a new template to record reference verification. Safeguarding knowledge is integrated into interview questions capturing new staff's understanding of safeguarding.

The decor and tidiness of the home are of a good standard. The home is well maintained and comfortable. No hazards related to poor maintenance or inappropriate storage were identified. The child's room is decorated to their own preference and is welcoming and reflects the child's interests



Feedback from professionals about the care and support provided was positive. The child's social worker also commented that 'the move [into the home] has been brilliant and the growth and progress has been amazing through the support of the staff, who understand her needs'.

At the last inspection, three requirements and two recommendations were made. The requirements and recommendations have effectively been addressed and met. As a result, the children are safer, are making progress and are being looked after by staff who better understand their needs. The manager has also applied to register with Ofsted.
