Monitoring visit

Inspected under the social care common inspection framework

#### Information about this children's home

A local authority owns and operates this home. It provides care for up to four children aged between 12 and 18 years. The children may have social and emotional needs. There are two children living at the home full time and a further two are supported in a shared-care arrangement.

The manager has been registered at this home since September 2021.

### This monitoring visit

The interim inspection on 14 December 2021 found serious and widespread concerns in relation to the matching of children and the suitability of agency staff.

Ofsted issued two compliance notices under section 22 of the Care Standards Act 2000. These were in relation to regulation 14, the care planning standard and regulation 32, the fitness of workers.

A monitoring visit on 24 January 2022 found that managers had not made sufficient progress to meet all the actions set out in the compliance notices. As a result, the two compliance notices were reissued.

The purpose of this visit was to assess the progress made to meet the compliance notices.

Staff help the children to feel more at ease and the atmosphere in the home is much calmer than before. One staff member said, 'The good relationships we have with the children have helped them to make progress.'

Staff work with other agencies, such as the police and therapeutic services, to improve their understanding of the children's needs. They also use regular conversations as a way of helping children to recognise unsafe situations. Some children are supported to return to live with their families because of the reduction in concerns.

Staff talk with the children about their complaints and grumbles about their experiences of living at this home. This ensures that the children feel listened to and supported to raise concerns. Follow-up discussions ensure that the children are happy with and understand the outcome.

Concerns about staff conduct and practice are carried out in line with local safeguarding procedures to protect the children from harm. The investigation process, in consultation with the local authority designated officer, is thorough. Partnership discussions about the actions taken are well documented. However, managers have not notified the regulator when these concerns have been raised. This prevents Ofsted from having oversight and assurance that the children are protected from harm.

Recruitment practice linked to checks on agency workers has now improved. This provides stronger assurances that agency staff are safe, suitable and have the skills and experience required to work at the home. Children are involved in the recruitment process and are supported to interview the prospective candidates.

Impact risk assessments now provide the manager with a framework to evaluate the children's suitability to live together. This reduces the risk of placement disruption and concerns for children escalating because of incompatible needs.

The actions set out in the compliance notices have now been met.
