This is a private children's home that provides care for up to eight children. The home's statement of purpose states that children living in this home may have a range of social and emotional difficulties.

The previous manager left their role in September 2021. The new manager registered with Ofsted in December 2021. She is appropriately experienced and qualified to manage a children's home.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At this interim inspection, Ofsted judged that it has improved effectiveness.

The manager has been in post since September 2021. She has made some significant improvements to the operation of the home and the quality of care provided to children. At the previous inspection, five requirements were made, and they have all been met. The manager has recruited new staff to ensure that there is a full core staff team in place, and she has established a stronger senior team. Consequently, the staff team has stabilised, and staff morale has improved.

Children and staff recognise the improvements that have been made since the change in managers. The staff team is proud of the children and the progress they make. Children are happier in their home. They have improved relationships with the staff and talk about them fondly.

Children have improved their relationships with each other. They appear relaxed and settled together as a group. Children engage in regular workshops and key-work sessions relating to anti-bullying. The sessions are pitched at children's different age groups and levels of understanding to ensure that they are effective.

Children now have up-to-date placing authority care plans on file. Children's placement plans are personalised to their individual needs. They reflect the aims and objectives requested by the placing authorities and are reviewed regularly to assess children's progress. This ensures that the staff team is working in accordance with children's current plans.

The staff team has improved their monitoring of children's health needs. Children's health records provide staff with detailed guidance on the internal and external support that children require to maintain good health. Staff educate children about healthy eating and food choices through interactive workshops. An in-house nutritionist works closely with the staff team to ensure that children are encouraged to follow healthy diets and lifestyles.

Since the last inspection, the use of restraint has significantly reduced. This is because the staff now work together consistently and help children to feel settled. Records are clear and accurate. The manager's evaluation of restraint records is reflective. She uses feedback from debriefs to identify when children are struggling and adjusts structures, incentives and strategies to support their positive behaviour.

The management of allegations is transparent, and they are appropriately responded to, including notifying relevant professionals without delay. Thorough investigations are implemented to safeguard both children and staff.



Incidents of children going missing from the home have significantly reduced since last summer. Children make safer choices and recognise the importance of staff knowing their whereabouts.

Children's bathrooms have not yet been refurbished and feel institutionalised. This was a recommendation at the last inspection and so this has been escalated to a requirement. In addition to this, some carpets in children's bedrooms and hallways require replacing. The general home environment requires some improvements to the décor to make it feel more homely.
