#### Information about this children's home

The home is owned and operated by a private organisation and can provide care for up to five children with social and emotional difficulties.

There has been no registered manager since October 2021.

## This monitoring visit

This monitoring visit was undertaken to review adherence with the suspension notice.

Following the last Ofsted visit, the provider liaised with the regulator as they recognised that they were not in a position to remain operational. The provider wished to temporarily close the home for a period of time. This was done while a new manager and staff team were recruited and the property was undergoing refurbishment.

Ofsted has imposed a condition on the home to allow the provider time to ensure that the service is fully operational before children are able to move into the home. When this notice comes into effect, the current suspension notice will be lifted.

The provider has recruited a manager and a deputy manager. The manager is in the process of submitting an application to Ofsted, and with the deputy manager is reviewing the action plans for the home to prioritise and focus their attention.

A refurbishment of the property is underway. Children's bedrooms have been redecorated, have new carpets, furniture and televisions and the manager has plans for welcome baskets to be made for each room. Children will be able to personalise their rooms to their own taste.

Bathrooms have had new showers installed and the kitchen diner has also been refurbished. The living room is a cosy and homely room. Maintenance personnel were in attendance on the day of the visit undertaking work to internal fire doors. The manager said there is further work to be undertaken in relation to ensuring they are compliant with fire precautions. The progress of this will be reviewed by the independent visitor as part of their review and will be a key line of enquiry at any future variation visit to ensure compliance.

The manager told the inspector that, at present, they have two members of staff identified to work in the home, and one newly appointed member of staff subject to safer recruitment checks. One of these staff has the required qualification. The provider is actively recruiting, and the manager and senior management team understand the importance of only employing safe and suitable staff. This will be a key line of enquiry subject to the home reopening. A recruitment professional has been employed to support the organisation's recruitment.

Requirements made at the last inspection were not looked at during this visit and have been repeated. However, progress has been made in respect of the requirement to appoint a manager and concerning the home environment, and these requirements have been met.

understand the roles and responsibilities in relation to protecting children that are assigned to them by the registered person;	
take effective action whenever there is a serious concern about a child's welfare	
that the home's day-to-day care is arranged and delivered so as to keep each child safe and to protect each child effectively from harm.  (Regulation 12 (1) (2)(a)(i)(ii)(iii)(v)(vi)(b)(d))	
If the Regulatory Reform (Fire Safety) Order 2005(a) applies to the home—	18 June 2022
the registered person must ensure that the requirements of that Order and any regulations made under it, except for article 23 (duties of employees), are complied with in respect of the home. (Regulation 25 (2)(b))
