This privately owned home provides a therapeutic model of care and education for up to four children who have had adverse childhood experiences. There is a school on site that is also run by the organisation. The inspector only inspected the social care provision.

The manager of the home registered with Ofsted in November 2017.

Inspection judgements

Overall experiences and progress of children and young people: good

Two children have moved out and one child has moved into the home since the last inspection. Two children are currently living at the home and are making good progress.

Both children have previously struggled to engage in education. Since moving into the home, they have achieved daily attendance at the provider's on-site school. They are engaging well, aspire to achieve qualifications and have goals for the future.

Staff encourage the children to take part in activities. The children enjoy go-karting, trampolining, bowling and trips out to parks. Such activities increase children's social skills and confidence.

Regular children's meetings ensure that time is spent gaining their views on future activities and plans for the home. Children are encouraged to discuss any issues or problems that they may have in these meetings.

Staff encourage the children to eat healthy meals. All meals are freshly cooked and attention is given to ensuring that the children eat enough vegetables and fruit every day. One of the children enjoys cooking and baking regularly with staff. He is learning valuable life skills alongside embracing the home's healthy eating plan. During this inspection, the child commented on how much healthier he now feels.

Staff support children to maintain relationships with the people who are important to them. One of the children enjoys spending time with friends in the community and the other child spends every weekend at home with their family. A parent said, 'I am extremely happy with the care that the staff provide. They are more like family. I have very good relationships with the manager and staff. My child has consistency at the home. The staff keep him active, are very supportive and communicate regularly with me.'

How well children and young people are helped and protected: good

The children say that they like living at the home and feel safe. A child said, 'My opinions really do get listened to here. I really like the staff. I have grown up a lot because of them. I now think more before I do things.'

No sanctions have been used since the last inspection. The home has an incentive scheme which enables children to increase their pocket money. Both children are responding well to this system, which reinforces positive behaviour.



Children's individual risk assessments are comprehensive, detailed and updated promptly. High-quality risk assessments provide staff with the necessary strategies to minimise potential dangers and protect children.

No children have gone missing from the home since the last inspection. The home has a detailed missing person policy, and each child has an individual plan. This ensures that essential details are known and that staff are aware of the procedures to follow should an incident occur.

Staff are skilful at de-escalating incidents, and physical interventions have reduced. When physical intervention is required for safety reasons, the incidents have been recorded promptly. The views of the child are gained and staff receive debriefs. However, on one occasion, the deputy manager, who was involved in an incident, completed the debrief with staff. This lack of independent scrutiny potentially compromises the integrity of the review.

The effectiveness of leaders and managers: good

The experienced and knowledgeable manager is supported by an equally committed deputy manager. They are ambitious for the children and ensure that meeting the children's needs is paramount and that consistent care is provided.

Staff receive good-quality supervision which prioritises the children's needs and the staff's professional development. Staff say that they feel well supported by the managers.

The managers and staff have developed good relationships with other professionals. A social worker described the communication as extremely good and praised the staff for the positive work that has been achieved. One of the children has a mentor, who visits twice a week. The mentor said, 'The staff are very accommodating and the home is welcoming. Communication is great. It is nice to see the consistency of staff is the same every time I visit.'

The staff attend monthly group supervision meetings with the provider's therapist. These meetings explore group dynamics and progress made and help staff to develop their practice further.

The manager has completed internal reviews of the quality of care provided for the children. These are comprehensive and detail actions for development. However, several of the reports have not been submitted to Ofsted as required.

The home was last inspected in January 2022. This latest inspection was brought forward due to Ofsted receiving a complaint from a local authority. The issues raised in the complaint were looked at during this inspection. One of the concerns raised related to failure to record an incident correctly initially. The manager acknowledged that the original report lacked detail and that further information was added following her review. A recommendation has been set.



The manager has met one of the requirements from the last inspection and the one recommendation. One requirement has been restated.



What does the children's home need to do to improve? Statutory requirements

Recommendation

The registered person should ensure that staff are familiar with the home's policies on record-keeping and understand the importance of careful, objective and clear recording. ('Guide to the Children's Homes Regulations, including the quality standards', page 62, paragraph 14.4)
