Summary of key findings

This provision does not meet requirements

- The provider, who is also the manager, does not have a secure knowledge and understanding of the requirements of her registration. There are several breaches to the statutory requirements of the early years foundation stage and the compulsory part of the Childcare register. These breaches have a significant impact on children's safety and well-being.
- The provider does not understand the importance of being fully alert to any issues of concern in children's lives at home or elsewhere. She assumes that other professionals, such as school staff, take the lead responsibility to safeguard children. As an example, she does not recognise the need to record or monitor any existing injuries that children may have when they arrive at her setting. This compromises her ability to monitor children's safety and welfare.
- Staff do not have a secure and up to date safeguarding knowledge. Although the provider and her deputy manager have attended safeguarding training, they are unable to demonstrate a secure understanding of how to implement this in practice. They do not have an understanding of wider safeguarding issues, such as extremism and peer-on-peer abuse. Consequently, they are not able to recognise and act on possible signs and symptoms of all types of child protection concerns. In addition, the provider has failed to ensure completion of designated safeguarding lead training (DSL). This is a breach of requirement and a safeguarding concern.
- The provider's husband, who is a member of staff, also acts as the named deputy manager. The provider, who is the, untrained, designated lead for safeguarding, demonstrates a poor understanding of her responsibility to safeguard the children in her care. In addition, neither of them takes into consideration that potential safeguarding issues can impact a wide cross section of society, including children and families who attend the provision. This has a significant impact on children's safety.
- The provider does not evaluate her provision effectively to identify areas that are not meeting requirements. The provider and her deputy do not undertake ongoing, targeted professional development opportunities to promote improvement of their knowledge, skills and understanding, in order to continuously develop and extend experiences for children.
- The paediatric first-aid certificates for all staff, including the provider, have expired. As a result, the provider cannot ensure that there is at least one person with a valid paediatric first aid certificate (PFA) at the provision with children at all times; or when children are on outings or being transported to and from school. This significantly compromises children's safety and well-being as staff cannot be assured that they are providing the most up-to-date care in the event of an emergency.
- The provider has not ensured that records are easily accessible and available for inspection purpose. This is with particular regard to insurance documents for vehicles in which children are being transported.
- Through discussion, the provider demonstrates a poor knowledge of the



necessary records to be kept. For example, she does not understand the importance of consistently checking and maintaining records that require personal information for all children are in her care. This compromises her ability to protect children's well-being.

- The provider understands the importance of working in partnership with parents. She talks confidently about how she communicates with them. The provider demonstrates how she shares information with parents about their children's experiences, through monthly newsletters.
- The provider talks confidently about how she plans activities that reflect the interests of children who attend the provision. She understands how to promote children's good health. For instance, she describes how she plans to provide various opportunities to promote their physical well-being, and the importance of providing children with healthy, nutritious meals and snacks.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

The provision is not meeting requirements and Ofsted intends to take enforcement action.

We will issue a Welfare Requirements Notice requiring the provider to:
