Summary of key findings

This provision meets requirements

- The childminder has very good knowledge and understanding of her duty to safeguard children and to protect them from harm. She has a clear safeguarding procedure and can recognise possible signs and symptoms of abuse. The childminder holds a recognised paediatric first-aid qualification.
- The childminder understands the importance of having effective communication with parents. She explains how she will gather detailed information before children begin at the setting. For example, she finds out about children's likes and dislikes. She uses information to provide safe systems, including protecting those with allergies from harm. The childminder also makes it a priority to find out whether children have individual needs based on their culture, such as any dietary requirements.
- The childminder reflects on her practice and is clear about the curriculum that she wants to provide for children in her care. She has a wide range of resources that incorporate the educational programmes. The childminder can list activities that appeal to children's interests and that will help them to good make progress. She knows how to plan a suitable range of age-appropriate play opportunities to inspire and challenge children.
- The childminder has robust systems in place to track each child individually and ensure they are meeting their developmental milestones. She recognises the importance of working closely with parents and other settings that children attend. She describes how this will help her to provide appropriate and consistent care and learning. If gaps are identified, the childminder has clear procedures in place to gain advice and guidance from external agencies.
- The childminder explains how she will promote children's good behaviour and will encourage them to be respectful in her home. She discusses how she will teach children to follow the simple rules and boundaries she has in place. For example, she will encourage them to be kind to each other. The childminder explains how she will promote children to be independent and responsible individuals.
- The childminder explains how she will promote children's health effectively. For example, she will work in partnership with parents to ensure that children benefit from healthy and nutritious snacks, meals, and drinks. Children will benefit from daily opportunities to develop their physical skills. For example, she plans on using the climbing equipment in the local park to help develop their large-muscle skills.
- The childminder describes how she will provide children with rich experiences that promote their understanding of the local environment. For instance, she plans to take the children to visit the local library. Children will be able to take part in guided sessions and can absorb themselves in activities that focus on literacy. The childminder explains how she will encourage children to socialise with others who may be unfamiliar to them, in order for them to build confidence and skills that will help them when starting school.
- The childminder is committed to her ongoing training and development. She



evaluates what works well in her provision and adapts the environment accordingly, considering the needs of individual children.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
