## Summary of key findings

#### This provision meets requirements

- The childminder is very self-aware and highly motivated. Her energy is reflected in the enthusiasm for the teaching and learning that children access. She continually strives to improve the quality of her setting through training and development of the environment. The childminder is passionate about the work that she does and the quality of care that she offers to the children.
- The premises are safe and secure. The childminder organises her home to meet the needs of children, including those with special educational needs and/or disabilities. There is a range of resources and toys available for children to access throughout the environment. The childminder ensures clear expectations of behaviour for keeping children safe, including while out on trips.
- The childminder speaks with confidence and demonstrates a sound knowledge of how to help children learn. She understands the importance of a sequenced and purposeful curriculum. For example, using tummy time with babies to prepare them for developing core strength ready for sitting.
- The childminder understands the way that children learn and how to offer teaching to meet the needs of the individual child. Children are closely monitored through effective planning and assessment to identify next steps in learning.
- The childminder is an actively involved member of the local community. As a result, children can access a wide range of experiences, such as yoga at the local community centre. This helps provide a rich and broad curriculum.
- The childminder works closely with parents and engages them in their children's learning. This includes offering advice and support to help them understand how to support their child's needs at home. This has a positive impact on children's outcomes.
- The childminder has secure knowledge of how to keep children safe. She has a good understanding of the different types of abuse and the signs and symptoms. The childminder understands the procedures to follow if a child is at risk of harm and how to share any concerns with other professionals.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
