Summary of key findings

This provision meets requirements

- The provider understands his responsibilities to protect children from harm. He ensures staff attend regular training, so they recognise when children may be at risk. The provider can identify the signs and symptoms of abuse and knows who to report his concerns to. The provider demonstrates a secure knowledge of the 'Prevent' duty. He shows a good understanding of how to spot indicators a child may be at risk of radicalisation. The provider is confident of the procedures to follow should he be concerned about a child.
- The provider demonstrates, through discussion, a secure understanding of how to keep the environment children access safe. He explains how staff will supervise children vigilantly. The provider explains how he completes visual checks of the area used by children, both indoors and outdoors, to ensure any risks and hazards are removed. The provider understands how to keep children safe on outings.
- The provider explains how he will encourage children to develop a healthy lifestyle. He ensures children have regular opportunities to be physically active and energetic in the outdoor space at the setting. The provider also explains how he provides opportunities for children to develop their physical skills at the local park. He encourages children to eat healthy foods by providing different snacks for children, such as fruit and vegetable sticks.
- The provider demonstrates a secure understanding of how to manage behaviour. He explains how he will support children to take turns and share with others. For example, he explains how when children want to use the computer, to make it fair, he will use a timer, so that each child has ten minutes. The provider explains how he will praise children when he sees them behaving in a positive way. He understands the importance of having clear behaviour expectations.
- The provider recognises the importance of finding out about children before they start at the setting. He explains how this helps children to feel settled if there are activities that they enjoy doing. The provider finds out from parents about any food allergies children have to ensure there is no risk of cross-contamination when food is prepared.
- The provider ensures all staff working with children are suitable. He follows robust recruitment practices. The provider completes ongoing performance appraisals with staff, to identify what they do well and how they can improve their practice even further.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
