Summary of key findings

This provision meets requirements

- The childminder describes her vision for children in her care and explains clearly how she will develop and deliver activities to support children's early education. The childminder's curriculum thinking is strong. She demonstrates how she will support children to develop in all areas of learning.
- The childminder explains that she will work closely with parents to help children to settle when they first start. For example, she will find out about children's routines at home and their favourite activities. She will discuss what children know and can do and use these as starting points to provide a challenging curriculum.
- The childminder has a strong knowledge of supporting children with special educational needs and/or disabilities. She describes the importance of an accessible and inclusive environment. The childminder understands the importance of working closely with parents and other professionals. She explains how working together will help to meet children's needs and decide on any additional support to help them reach their full potential.
- The childminder understands the importance of building children's self-confidence. For example, she will help them to express themselves and make relationships with other children. She will teach children about what is right and wrong by being a positive role model. For example, she explains she will play alongside and talk to them about sharing, 'It is your turn first, then my turn.'
- The childminder understands how to safeguard and protect children's welfare. She is confident about recognising signs that may indicate a child is at risk of harm and knows how to report any concerns. The childminder explains how she will teach children to keep safe, such as how to evacuate the house in case of a fire.
- The childminder has kept her knowledge and understanding of the early years foundation stage up to date. She has completed mandatory training, such as paediatric first aid and safeguarding.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
