Summary of key findings

This provision meets requirements

- The childminder understands how young children learn and develop. She explains how she would plan exciting activities based on children's needs and interests. The childminder has a range of age-appropriate resources for children to access. She describes how she would share children's ongoing progress with parents in a variety of ways. The childminder indicates that she would actively seek parent's feedback to help children achieve well.
- The childminder describes how she would help children to develop a healthy lifestyle. She intends for children to be active in her garden and at the local park on a daily basis. The childminder would encourage children to carry out hygiene routines, such as regular handwashing.
- The childminder explains how she would help children to behave well, through a variety of positive approaches. She describes how she would promote children's understanding of her expectations by setting clear boundaries. She would help children to understand their emotions and talk about why they may feel a certain way. She describes the importance of children considering how their actions may affect others.
- The childminder explains how she plans to develop children's social skills and confidence, particularly in new situations. For instance, she would take children to local playgroups and the library to meet and interact with others.
- The childminder knows the importance of effective partnerships with other settings children may attend as well as the local schools that they will move to. She understands how to seek advice and support from other professionals. This includes the use of strategies to help children who may show persistent gaps in their learning.
- The childminder understands her responsibilities to protect children from the risk of harm. She knows the local procedures to follow, to seek advice or report a concern about a child's welfare. She is also aware of what to do if an allegation is made about her or a household member. The childminder describes how she would ensure the learning environment is safe and secure for children. For example, she would carry out daily risk assessments of both indoor and outdoor areas.
- The childminder discusses how she intends to keep her knowledge up to date and research for fresh ideas to use in her setting. She would consider parent's views through the use of questionnaires as she makes plans for ongoing developments.
- The childminder has a good understanding of how to develop children's language and communication skills. She plans for children to sing, share books and hear new language throughout the day. The childminder intends to raise children's awareness of other cultures and languages. She would encourage children to share their own home languages and cultures. Additionally, the childminder would talk about her own home languages, which include Dutch, English and Arabic.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
