Summary of key findings

This provision meets requirements

- The provider understands the importance of the safe transition of children from school to the club. For example, staff share additional information that may support the children who attend.
- The provider demonstrates a good knowledge of how to promote healthy lifestyles. For instance, staff understand the importance of regular access to outdoors and opportunities for physical exercise. They recognise the need to promote healthy eating practices, providing a healthy range of snacks and supporting children in learning about portion size.
- The provider recognises how to support children's behaviour and their developing respect for each other. For example, staff are familiar with the 'Buddy' system to build children's self-esteem, confidence, and awareness of
- The provider is aware of the importance of supporting inclusivity and developing children's understanding of diversity. For example, they describe activities in the past to celebrate different national days and cultural celebrations. They have also celebrated differences and similarities within their community.
- The provider knows the importance of building strong relationships with parents and providing a key-person system to support the needs of all children. They describe information sharing, such as emails and noticeboards and ways to support children consistently.
- Staff receive regular supervision and support from managers, providing feedback and identifying areas for improvement. Staff have regular access to training to support their continued professional development.
- The provider makes sure robust recruitment procedures are in place, ensuring the ongoing suitability of staff. They make sure that staff have the required qualifications, skills and a clear understanding of their roles and responsibilities. The provider conducts thorough risk assessments to ensure the continued safety of the children.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
