## **Inspection judgements**

#### Overall experiences and progress of children and young people: good

Following a full refurbishment, children now live in homely and comfortable surroundings, having been involved in choosing colours and decoration that help them feel fully involved in the way the home looks and is run. The children look after the house rabbit and grow vegetables, and the home fits suitably alongside those in the local community.

Both children have made progress, despite difficult personal circumstances, through supportive, caring and considerate relationships with the permanent staff team. Significant progress has been made in terms of health, diet, routines and boundaries. A range of exciting activities and trips are captured sensitively in memory books and alongside diaries that demonstrate children's progress and celebrate the positive things in their lives.

Time with family members is supported well and in a way that best suits the children. The staff team has created an environment where children are opening up about how they feel about difficult subjects and learning how to manage their emotions in more positive ways.

One child has moved into the home since the last inspection and has been supported well through family court processes. Despite multiple changes of social worker and uncertainty about the plan for her future, staff have created a sense of stability at a time of change. This is well supported by the input of the home's therapist.

Going to school on a regular basis has been difficult for one child to maintain, but they have completed school work online daily, supported by staff. The manager has advocated well for increased support from the virtual school in terms of equipment. However, in the run-up to examinations, all the professionals involved need to increase their focus on how to support this child back into the classroom.

#### How well children and young people are helped and protected: good

From the point that new children arrive, the impact on the home and how to manage a change in dynamics is carefully assessed. Shortly afterwards, these risks are revisited, and practical plans are put in place to support children to understand the impact of their behaviours. As a consequence, the home does well at mitigating the impact of previous harm on children. This has also helped managers and staff to identify strategies aimed at protecting children from present or future risk.

Following a settled period, both children recently reacted to upsetting news about their families by going missing and physically challenging staff members. This was dealt with well, children were supported to return home. The police were appropriately informed and involved, and direct work has taken place to help



understand the reasons behind these behaviours. Consequently, by the time of the inspection this period had calmed.

Staff are alert to the risks of online exploitation and support children well to develop ways of keeping themselves safe. When risks from people outside of the home are identified, other professionals are kept informed and alerted to the risks posed to other children in the community. Risk management meetings are convened quickly and are used to focus safety plans on the most important issues for children.

The new staff team has been recruited safely and offers a broad range of skills that give children several options about who to confide in when they are struggling. Staff were observed reacting to triggers and cues that signified changes in the children's mood, and to support, comfort or divert accordingly.

The home itself is safe and secure. Minor issues regarding the process for ensuring that sharps are locked away and keys to the home are kept safe have been addressed promptly.

#### The effectiveness of leaders and managers: good

The manager of the home has overseen a successful overhaul of the house and the staff team since the last full inspection. The manager is currently going through the registration process with Ofsted and the responsible individual has offered regular, additional support while awaiting the completion of this process. A detailed and regularly updated development plan demonstrates that the children are central to the planning and the ethos of the home as laid out in its statement of purpose.

A mixture of experienced and new staff have had a well-structured induction that includes all key issues relevant to the needs of the children that live in the home. Further training in identifying anxiety, contextual safeguarding, self-harm and promoting empathy have had a positive impact on how the children are cared for.

The manager responds positively to the findings of the monthly independent person reports. Notifications to the police and to Ofsted were not always made at the time of the last inspection, but this and other requirements have been addressed. There have been several examples of the manager advocating for children effectively and escalating issues to the local authority social worker and managers. In one case, the promotion of education in school requires further attention.

Supervision is regular and staff report positively on the ethos of the home and the leadership of the manager. Records of supervision could be more detailed, but staff demonstrate a good understanding of what the children need and what is expected of them.
