## Summary of key findings

### This provision meets requirements

- The childminder understands how to provide activities based on all areas of learning. She understands how to monitor children's development. The childminder knows how to use this information to give children the right challenges to support good progress.
- Through discussion, the childminder describes how she would help children to understand and respect difference. She explains how she would teach them to have regard for themselves and others. The childminder understands how to manage children's behaviour effectively.
- The childminder knows how to prepare nutritious meals and snacks for children. She understands the value of ensuring that children have daily opportunities to support their physical development.
- During discussion about child protection, the childminder shows that she is aware of how to identify any signs and symptoms that a child may be at risk of abuse. She knows procedures to follow to report any concerns to protect children from harm.
- The childminder knows how to evaluate her practice and to put clear goals in place to build ongoing improvements. She describes the training courses she intends to complete, such as developing her understanding of how to meet the needs of children with special educational needs and/or disabilities.
- The childminder has ensured that she has kept her paediatric first-aid training current and has suitable insurance in place.
- Through discussion, the childminder describes how she would share information with parents about their children's progress and provide ideas for how to support their learning at home.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2005. She lives in Brentford, in the London Borough of Hounslow. The childminder would offer care for children from Monday to Friday, 7am to 6pm, all year round, except on public bank holidays. The childminder holds a level 3 qualification in childcare.

### Inspection activities

- This was the first routine inspection the childminder received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the childminder and has taken that into account in their evaluation of the setting.
- The inspector viewed the premises, toys and resources with the childminder. She talked with the childminder about how she will use these to promote children's learning.
- The inspector viewed relevant documentation, which included the childminder's paediatric first-aid qualification, insurance and Disclosure and Barring Service checks for adults living in the home.
- The inspector spoke with the childminder to find out how she would use experiences and activities to support children's learning and development.
- The inspector talked with the childminder about her safeguarding knowledge and how she will keep children safe.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
