Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 1. Quality of education provided

Paragraphs 2, 3

- The school's curriculum and assessment policies are suitable.
- There are schemes of work covering all the required areas of learning for pupils aged 11 to 16. These show the knowledge and skills that pupils, including those with special educational needs and/or disabilities, are expected to learn as they progress through the school.
- A suitable personal, social, health and economic (PSHE) education programme is delivered on a weekly basis to all pupils. It is based on a commercial scheme of work and resources. Pupils are encouraged to respect the range of differences that people have.
- All the requirements for relationships and sex education are met.
- A broad programme of careers education helps to prepare pupils for their future. An external organisation is commissioned to provide pupils with impartial careers information, advice and guidance.
- The school is suitably staffed and resourced. This inspection identified no concerns about the quality of education.
- The independent school standards in this part continue to be met.

Part 2. Spiritual, moral, social and cultural development of pupils

All paragraphs

■ The school's PSHE education curriculum is suitable. It promotes fundamental British values and pays regard to the full range of differences people have, including all the protected characteristics identified in the Equality Act 2010. Pupils spoke of their learning about mental and physical health, online safety and healthy relationships.



- The PSHE education programme is complemented by a programme of assemblies, themed days and outings. Pupils are taught about a range of religions, faiths and cultures. Tolerance and appreciation of the diversity of modern British society are actively promoted.
- An extracurricular programme of clubs provides pupils with a range of additional creative and sporting opportunities.
- Teachers follow clear guidance to avoid the promotion of partisan views. They know to offer a balanced presentation of opposing points of view in the teaching of any political topic.
- The independent school standard in this part continues to be met.

Part 3. Welfare, health and safety of pupils

Paragraphs 7-7(b), 9, 10, 11, 13, 14, 16

- This inspection identified concerns about the school's safeguarding arrangements. Leaders do not meet their obligations for all pupils on the school's roll. The recording of actions taken in the light of safeguarding concerns is not thorough enough. There are systemic weaknesses in how well the proprietor and governors communicate with, and check the work of leaders with responsibility for safeguarding. These requirements are no longer met.
- The school's behaviour and anti-bullying policies are implemented well. Bullying is dealt with effectively should it occur. Rare incidents of serious misbehaviour, and any sanctions imposed, are suitably recorded. These requirements continue to be met.
- The school's health and safety policy is not implemented well. Unlocked cupboards containing cleaning chemicals are accessible to pupils. This requirement is no longer met.
- The school's first-aid policy is implemented well. There are a number of qualified first-aiders who administer first aid when required. Any accidents and provision of first aid are recorded appropriately. This requirement continues to be met.
- During a recent school outing, pupils were not properly supervised. The implementation of the planned risk assessment was not good enough. As a result, pupils were put at risk. However, serious lessons have been learned. Staff have had further training and the risk assessment process has been strengthened. These requirements continue to be met.
- Some of the independent school standards in this part are no longer met.

Part 5. Premises of and accommodation at schools

Paragraphs 23(1), 23(1)(c), 24(1), 24(1)(b), 25, 28(1), 28(1)(d)

■ The premises are in a generally good state of repair. The school's suitable closed-circuit television (CCTV) camera policy is implemented well. However, leaders do not pay enough attention to detail in ensuring that the building is cleaned thoroughly, including the pupils' toilets and showers.

- The school's shower facility is not available for pupils to use because it is being used as a storeroom for physical education equipment.
- Some shower cubicles have been converted into storerooms for cleaning products, such as bottles of sanitiser. These rooms were unlocked and these products were therefore accessible to pupils.
- The medical room washing facility had no hot-water supply and no soap.
- The hot-water supplies in the washing facilities in staff and pupils' toilets are not regulated. These present a scalding risk.
- Some of the independent school standards in this part are no longer met.

Part 6. Provision of information

Paragraph 32(1), 32(1)(c)

- The school's safeguarding policy is available on the school's website.
- This requirement continues to be met.

Part 8. Quality of leadership in and management of schools

Paragraph 34(1), 34(1)(a), 34(1)(b), 34(1)(c)

- This inspection identified complex weaknesses in leadership, management and governance.
- The proprietor and members of the governing body are involved in overseeing a number of ongoing investigations arising from concerns and grievances.
- There is not enough communication between members of the governing body, the proprietor and senior leaders. Consequently, members of the governing body and the proprietor are not aware of some important safeguarding information.
- Leaders and the proprietor have failed to ensure that all the independent school standards are met consistently, including in relation to safeguarding, health and safety, and premises.
- Leaders and the proprietor are over-reliant on external contractors for the maintenance of the premises, including cleanliness. They are not sufficiently familiar with the independent school standards in relation to premises and accommodation.
- The independent school standard in this part is no longer met.

Information about this school

- Al-Khair School is an Islamic independent day school for boys aged 11 to 16.
- The executive headteacher of the school is also the executive headteacher of Al-Khair Secondary Girls School. These schools are in the same building. The boys' school is on the ground floor and the girls' school is on the first floor. The schools have the same proprietor. They share facilities, such as the science laboratory and sports hall. They also share members of staff who teach in both schools, and the same website.
- The school does not make use of any alternative provision.

- In the near future, the proprietor intends to extend the school's premises into the neighbouring building, but has no plans to increase the number or the age range of pupils.
- The school's most recent inspection was a full inspection in October 2021, when its overall effectiveness was judged to be good.



Information about this inspection

- This emergency inspection was commissioned by the Department for Education in response to information that raised wider concerns about some aspects of the school's work.
- The inspection was conducted in parallel with an inspection of Al-Khair Secondary Girls School, which shares the same site.
- The inspection was conducted without notice.
- The inspector was asked to report against some of the requirements contained within parts 1, 2, 3, 5, 6 and 8 of the independent school standards.
- The inspector met with the executive headteacher, the chief executive officer, the proprietor and three members of the governing body. He also met with two groups of pupils and a group of staff.
- The inspector also spoke by telephone with the local authority's designated officer for safeguarding.
- The inspector toured the premises and reviewed key documentation, including documents related to safeguarding, health and safety, and risk assessment.
- There were not enough recent responses to Ofsted's online survey for parents and carers, Parent View, to consider as part of this inspection.
